The purpose of this email is to inform you of a Residential Remodel and Addition Project located at the address received above. Is our intent to submit for Conditional Usr and Technical Demolition Permits. Additionally we request a waiver of the 30 days period required before the applications can be submitted. If the Waiver is approved, we wish to file on or before January 17th 2018, and to present at the PCM on March 05th 2018. Today, I had the Pre-application meeting with Jenny Kirchgatter (Zoning) and Sidney Prusak (Pkanning).
