RE: EXCESSIVE ASSESSMENT Vincent J. Falcone, von Briesen & Roper, SC, attorney for Madison Malls Ground, LLC – Excessive Assessment - \$154,913.22

Claimant Madison Malls Ground, LLC, is claiming a refund for excessive real property tax pursuant to Wis. Stat. § 74.37 for their 2023 taxes for their property located at 89 East Towne Mall. The claimant alleges that the assessed value should be no higher than \$26,000,000 for 2023, and the property taxes should be no higher than \$475,240.03. The Claimant seeks a refund of \$154,913.22 plus interest.

The City Assessor valued the property at \$36,088,600 for tax year 2023. The Claimant challenged the 2023 assessment before the Board of Review, and they lowered the assessment to \$34,480,000. The 2023 real property taxes were \$630,153.25. The Claimant also alleges that the assessed value of the property established by the Office of the Assessor and sustained by the Board of Review violates Article VIII, Section 1 ("Uniformity Clause") of the Wisconsin Constitution.

I have consulted with the Office of the Assessor, and we are of the opinion that the Board of Review determined the appropriate assessed value for 2023.

For the foregoing reasons, I recommend denial of the subject claim.

NOTE: This claim was received on January 29, 2024, and pursuant to Wis. Stat. § 74.37(3)(a) if no action is taken on this claim by the Common Council within ninety (90) days of filing the claim, it is considered disallowed.
