NOTICE OF PUBLIC HEARING

Metro Transit - Proposed Increase to Fares Wednesday, November 7 at 6 PM

Madison City County Building, RM 201 (Madison City Council Chambers)

210 Martin Luther King Jr. Blvd.

On Wednesday, November 7, Metro Transit and the City of Madison Transit and Parking Commission will hold a public hearing at 6 PM to discuss proposed increases to all Metro fare items.

This fare increase is being proposed to go into effect on Tuesday, January 1.
