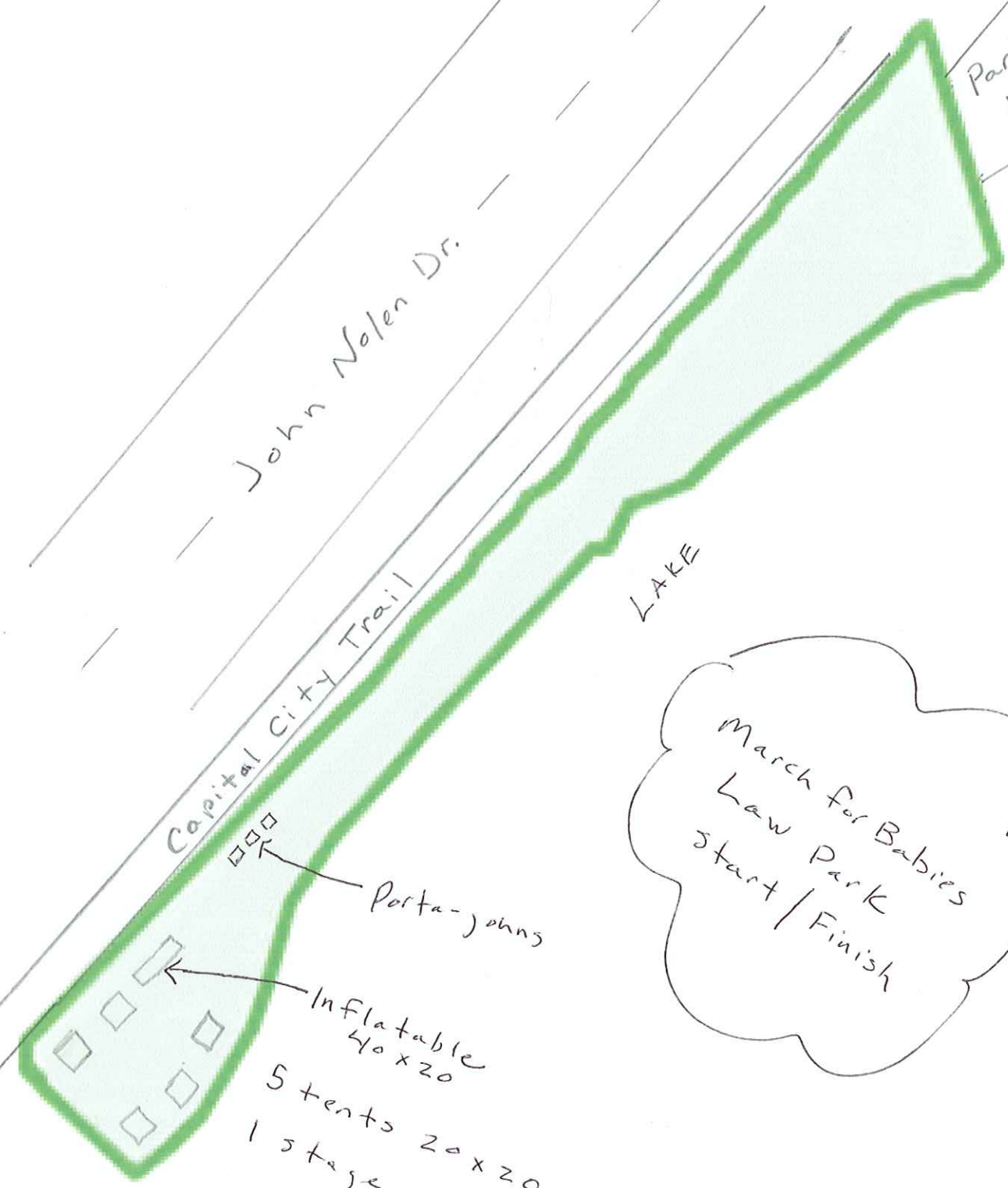

Continue toward Olin Park ~~from~~ the Capital City Trail.

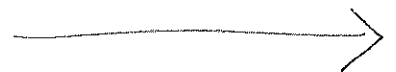
2nd check point at Entrance to Olin Park

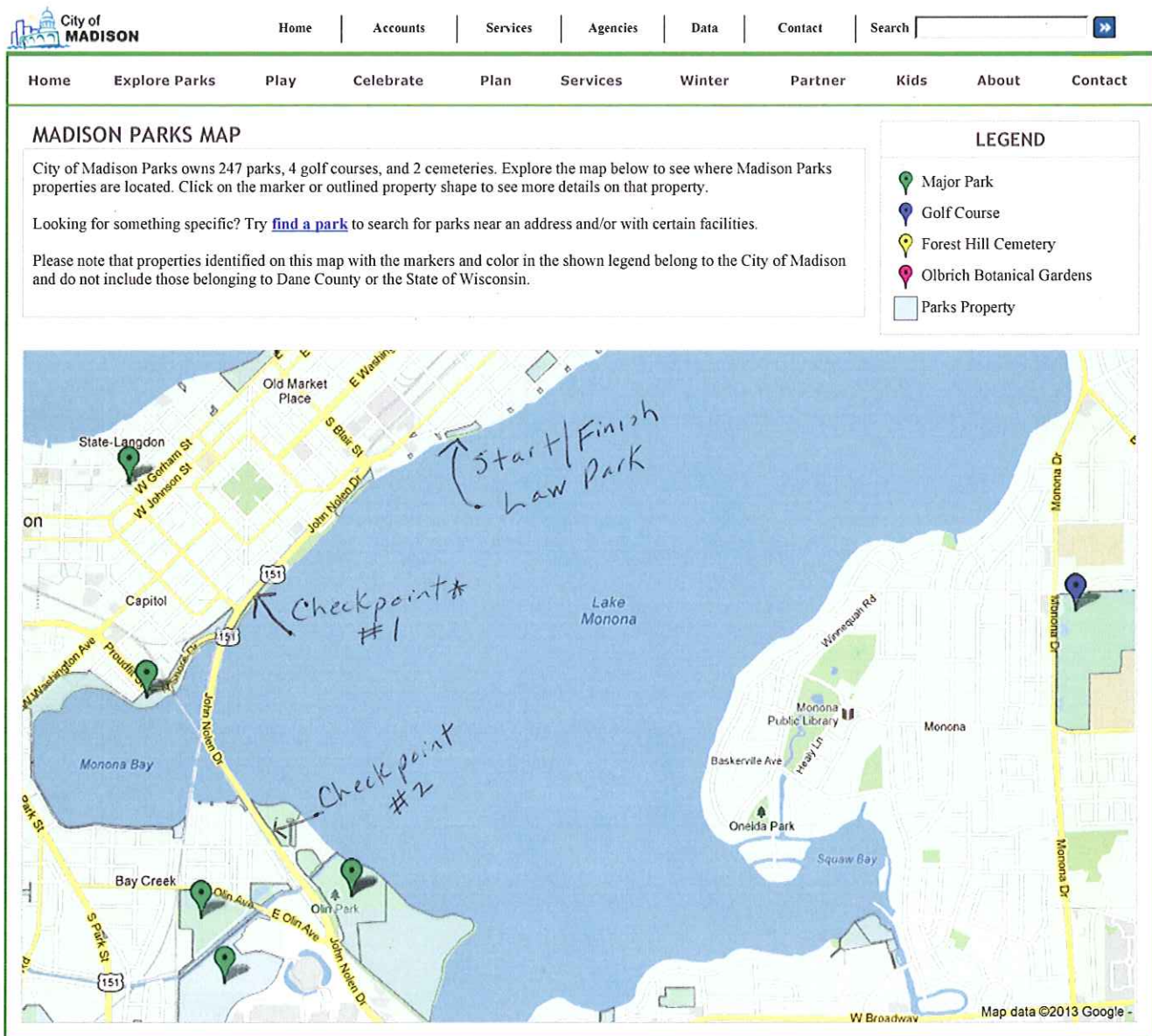
Enter Olin park cross Olin-Turville Ct and follow Olin-Turville Ct on the sidewalk heading south.

Take a right on to Heritage Trail and follow past boat landing and cross parking lot to ^(rt) bridge over creek to E. Lakeside St.

3rd check point just before bridge to E. Lakeside St.



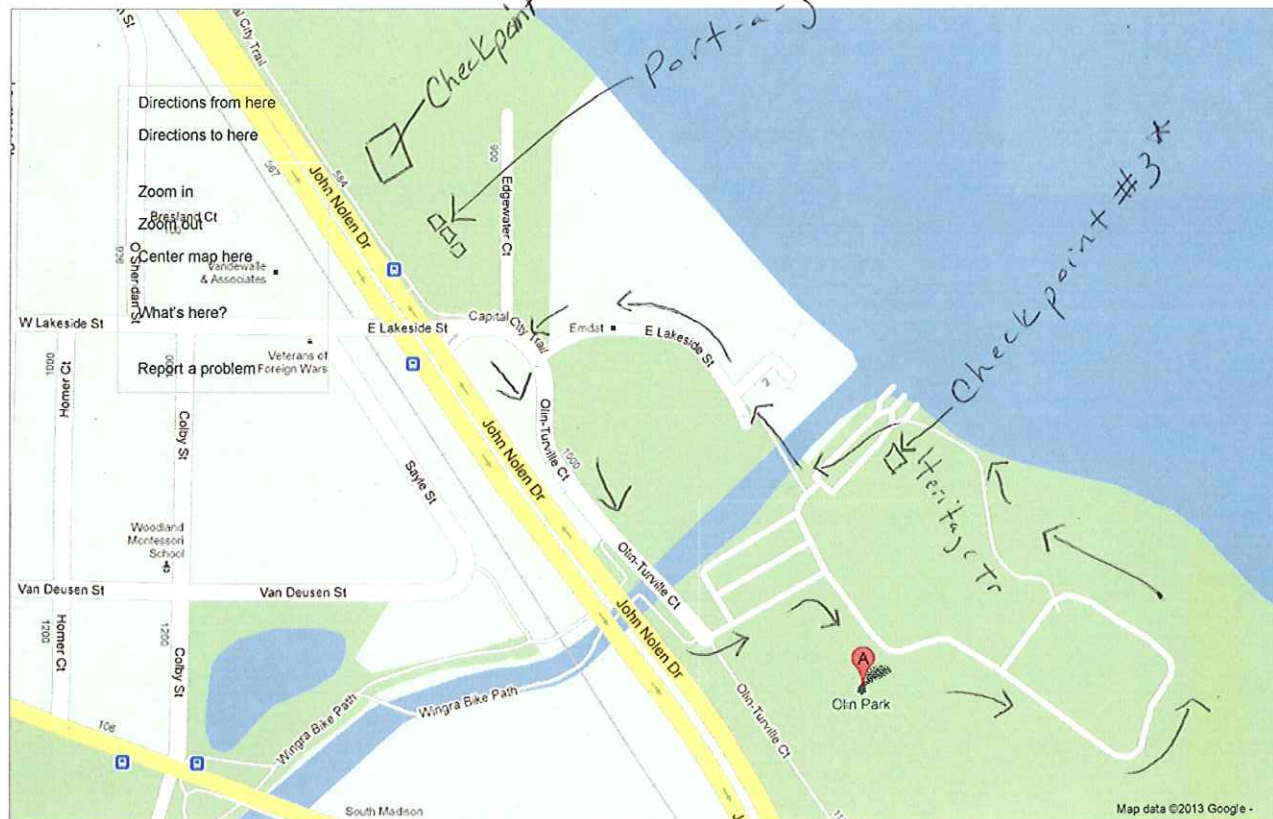


March for Babies Route
