Captain Ackeret and Assistant City Attorney Paulsen will continue to research camera companies. Alder Skidmore requested to assist with the research. Discussion took place on what would be the requirements for cameras in

convenience stores such as the pixels, clarity, number of cameras and costs. In order for members on PSRC to understand the different pixels with quality of film/video it was requested to share visual aides at an upcoming meeting to see the difference. A report will be shared with the PSRC once additional research has been completed.
