Pest Management Report - 2004

Introduction

In 2004, the Common Council revised the Policy Regarding Pest Management on City Property with the purpose of eliminating or further reducing pesticide use to the greatest possible extent. Reduction of pesticide use is important because misuse or overuse of pesticides is both an environmental problem and a public health issue. As required in the above policy, the following report summarizes the discussions of the Pest Management Advisory Committee regarding pesticide use by, and pest management plans for, agencies maintaining City property. This Committee is tasked with assessing reports and plans from each City agency managing pests on City property. The results of this assessment are then sent to the agency's director and Integrated Pest Management (IPM) Coordinator, the agency's oversight committee or commission, the Mayor's office, and the Common Council. It is the responsibility of these individual's and groups to take the appropriate action regarding an agency's compliance with the City's Policy Regarding Pest Management on City Property.

Results - General findings

- Many agencies were not in compliance with the Policy because their contractor, Terminix, failed to provide a summary of pesticide use and pest management activities conducted during 2004. Committee staff is working with the IPM Coordinators and the City Purchaser to correct this problem in the future.
- The Committee recognized that some IPM Coordinators would benefit from a standard template for preparing a pest management plan. Committee staff will prepare such a template and distribute it to agency IPM coordinators prior to the next round of reporting and planning.
- The Committee found that a number of agencies did not adequately justify their use of pesticides. According to paragraph 3 of the Policy, chemical pesticides are justified if:
 - 1. Alternative methods are ineffective and
 - 2. The pest has exceeded a given threshold causing health, safety, or reduction in the intended use of the property.

Agencies should address these two issues when justifying pesticide use.

• In order to be successful, IPM coordinators must have the authority to alter existing plans and take action to remedy a pest problem. To ensure that these actions are compliant with the intent of the City Policy, it is important for the

IPM Coordinators to receive appropriate training to allow them to base decisions on sound science.

	flies, can knock down flying adults but has not residual control.
	Control may be improved by determining the species of fly and
	tailoring control methods to fit that species. Staff should
	consider use of traps or other mechanical means of adult fly
	control.
