OFFICER NARRATIVE

On 05/09/09 around 1:30 am, I was on routine patrol when I noticed that a food cart by the name of Jin's Chicken and Fish was set up at a metered parking spot in the 300 block of N Frances St directly opposite of Ian's Pizza. I have had past contact with the vending coordinator for the city, Warren Hansen, who had notified me that vending is no longer allowed in the 300 block of N Frances St with the exception of those vendors who have assigned slots. Currently there are no assigned vendors in the 300 block of N Frances St. Vending coordinator Hansen also informed me that Okafo has an assigned slot in the 700 block of State St which is commonly referred to as library mall. Furthermore, vending coordinator Hansen informed me that he had mailed Okafo the map of the late night vending area, as well as the notice that the 300 block of N France St was no longer an open vending area. Hansen also informed Okafo that he is now vendor F10 and that F10 was located in the 700 block of

State St.

On 04/24/09, I personally made contact with Okafo who was set up in the same location vending and I informed him that the 300 block of N Frances St was no longer open vending. On 04/24/09, Okafo informed me that he had not yet been notified.

Tonight, Officer Javier Loreda, Officer Steve Magyera and myself went to the food cart to contact Okafo. I explained to Okafo that he was not allowed to vend in the 300 block of N Frances St and Okafo told me again that he has never been notified that he cannot vend in the 300 block of N France St. I told him that I understood what he was saying but that I did not agree with him and that vending coordinator Hansen told me that he had both mailed notification and spoken to Okafo on the phone notifying him of where he is supposed to be vending. Therefore I did issue Okafo a citation for late night vending violation.

There were two other individuals in the food cart that were also vending. I identified the first one with a Wisconsin DL as Fredrick Tevis O'Hara. I explained to O'Hara that he could not vend in the 300 block of N Frances St. Okafo tried to interrupt me and say that he would "take care of the ticket." I explained to Okafo that while indeed he is the owner of Jin's Chicken and Fish, I was issuing O'Hara a citation and it was up to O'Hara what to do with that citation and that I would not be giving the copy of O'Hara's citation to Okafo. I then did hand O'Hara his citation and explained to him how he could either pay the citation or appear in court.

The other employee vending that night identified herself to me verbally and I later confirmed it through Wisconsin DOT. Her name was Autumn Smith. I also explained to Smith that she could not vend in the 300 block of N Frances St. I then issued Smith a citation for a late night vending violation and explained to her how she could either pay the citation or appear in court.
