Assistant Attorney Anne Zellhoefer started out by explaining that the section of the State Statutes on prevailing wage was made null and void by Governor Walker so that is something we no longer enforce, but the City still does enforce the prevailing wage requirements through the Davis Bacon Act for federal funding. Anne spent time explaining how Tax Incremental Districts are formed, how blight studies are conducted to determine "blighted areas", and

how all entities such as MMSD, County, MATC, and the City have to agree to create a Tax District.

The Commissioners asked numerous questions about TID 32, specific projects such as the Edgewater Hotel and affordable housing. Commissioners wanted to know who the CDA members are. Staff will send them this list. Discussion was held about the separate authority and powers of the CDA vis a vis the City.

Norman Davis, Affirmative Action Division Manager, will report on activities of the Division since the last meeting.

Norman Davis, Affirmative Action Division Manager reported that the 2012 At A Glance report is being finalized. This report has the statistics for the different AA programs for 2012. It should be ready for the next AAC meeting. SBE has a net increase of 85 firms. The directory was re-published last Friday and there are now 241 SBE's. Notices have been sent out and those who don't apply will be decertified and those that apply will be in the directory. Dana Hannaman, who the Commission met at the last meeting, is doing well and has weathered the prequalification period for AA plans. Norman got to present information regarding the Job Skills bank, a database for interested employees, at the Madison Urban Ministry. The Kitchen Incubator project has approximately 10% M/W/DBE utilization goal, and Operation Fresh Start might be able to work on this project.
