I, John S Hausbeck, Environmental Health Services Supervisor for Public Health Madison and Dane County, do hereby depose and say that the Board of Health for Madison and Dane County at the board meeting on the fourteenth (14<sup>th</sup>) day of November 2013 voted to raise a total of \$206,909.55 from property owners with private septic systems in Dane County. The amount collected within each Dane County municipality is reported in the table on the following page. You are hereby requested to assess this fee against the properties in Dane County that dispose of wastewater via private septic systems. The authority to raise this assessed fee on the tax bill was provided by the Dane County Board of Supervisors on the sixteenth (16<sup>th</sup>) day of November 2009 by approving ordinance amendment 38, 09-10.
