This contract is for the preliminary design, environmental reporting, final design, plans, specifications and estimates for the reconstruction of Mineral Point Road from USH 12 to S High Point Rd.

## 1. Guidelines for RFP Evaluation

The City of Madison solicited proposals from qualified vendors through a Request for Proposal (RFP) process. The RFP and associated materials were posted on the City Engineering website and on two distribution networks, VendorNet and DemandStar, on July 7, 2023. RFP responses were due back on August 4, 2023.

Proposals were reviewed by a selection panel.

Qualification factors were weighted as shown.

Project Team 25%

Design Approach 30%

Local Preference 5%

The technical evaluation panel was composed of 5 City Staff from the Engineering and Traffic Engineering Divisions. Costs were obtained in the proposal. It was stated in the RFP that the City will choose the proposal which best combines the necessary qualifications with the value for expenditure of public funds.

## 5. Evaluation Structure and Scoring

Evaluation for this RFP was conducted in one round. The technical evaluation panelists each performed their evaluation independently and the results were averaged. The final recommendation was based on the highest average of those scores.
