#### Dear Licensing Staff:

I am writing on behalf of my client, Paco's Tacos LLC, doing business as Paco's Tacos (the "Licensee"), which holds a current Class B Beer and Wine License (No. LICLIB-2019-01230) for the premises located at 1331 Greenway Crosse, Madison, WI. As the Licensee's legal counsel, I am submitting this application to request a change in the conditions of the license pursuant to the City of Madison's alcohol licensing, where outlined in the Code of Ordinances Chapter 38 and related guidelines.

The current license conditions restrict alcohol sales to no later than 10:00 pm Sunday through Thursday and midnight on Friday and Saturday. The Licensee seeks to amend these conditions to permit alcohol sales until 2:00 a.m., Monday through Sunday. This proposed extension aligns with permissible hours under Wisconsin Statutes \$ 125.32(3) for Class B retail licenses and is intended to better accommodate the Licensee's restaurant operations for events and retail sales during open hourse, while maintaining compliance with all public safety and nuisance prevention requirements. The Licensee has reviewed the potential impacts on the surrounding community and is committed to responsible service practices, including adherence to beverage server training mandates.

Enclosed for your review and processing are the following:

- •Completed Change of Conditions application form (REV 09/2018), including a description of the proposed changes, licensed premises information, company details, and authorized signature.
- •Check in the amount of \$25.00 payable to the City of Madison to cover the application fee (shall be mailed or paid by phone if the City prefers).
- •Copy of the Licensee's current Wisconsin Seller's Permit certificate.
