**WHEREAS**, on February 14, 2006, the Transit and Parking Commission held a public hearing regarding proposed Parking Utility rate changes; and

**WHEREAS,** the Transit and Parking Commission, upon consideration of information obtained as a result of the public hearing, approved the Parking Rate changes on February 14, 2006; and

WHEREAS, on April 11, 2006, the Transit and Parking Commission (TPC) began consideration of Ordinance ID #03199, which included changes to certain parking meter zones and implemented the Parking Utility Rate Schedule approved by the Commission on February 14, 2006; and

**WHEREAS,** on May 9, 2006, public testimony was received on said Ordinance ID #03199 and associated zone and rate changes; and

WHEREAS, on May 9, 2006, the Transit and Parking Commission, upon consideration of information obtained as a result of the public testimony, recommended for adoption a substitute Ordinance ID #03199 and associated rate changes; and

**WHEREAS,** on May 16, 2006, the Common Council approved Ordinance ID #03199 and a revised Parking Rate Schedule as shown on the attached Parking Rate Schedule; and

**WHEREAS**, said parking meter zone and parking rate changes took effect on June 1, 2006;

**NOW, THEREFORE, BE IT RESOLVED,** that the attached Madison Parking Utility Parking Rate Schedule effective June 1, 2006, reflects the official rate schedule of the Madison Parking Utility as previously adopted.

#### Notes:

(a) Presently, the Evening/Weekend Maximum rate is \$2 at the Overture Center, State Street Campus and State Street Capitol ramps; and \$1 at the Government East and Capitol Square North ramps. This rate will increase to \$3 at all ramps. Note: Parking ramps can be used free of charge between the times of 1 a.m. and 7 a.m. on days when a snow emergency has been declared.

The Evening/Weekend Maximum rate applies to cashiered parking during the following time periods ....

- Hours parked after 6 p.m. weeknights (until 5 a.m. the following day); and

- Hours parked on Saturdays/Sundays (from 5 a.m. until 5:00 a.m. the following day)

(b) All ramps and surface lots will be enforced 24/7.

(c) On-street meters will be enforced from 8 a.m. to 6 p.m. and possibly longer at certain locations such as near the Kohl Center and Overture Center.

(d) Eligible carpoolers qualify for the (discounted) Monthly Resident rate and are entitled to immediate occupancy in select ramps.
