### Text of Legislative File 08387

#### Fiscal Note

No appropriation is required. Any difference in salaries will be absorbed through salary savings. There is no impact upon cost controls.

#### Title

Amending the 2008 Public Health Operating Budget by the deletion of a vacant 1.0 FTE LTE Emergency Preparedness Coordinator, and increasing the half-time LTE Community Relations Specialist position to full-time status.

**Body**

Preamble: In the 2008 Public Health Operating Budget, the LTE Community Relations Specialist was reduced from a full-time to a half-time position. The position of LTE Emergency Preparedness Coordinator has recently been vacated. With this resolution, funding and job function is transferred to the LTE Community Relations Specialist and it is increased to full-time. The duties of the two positions are very compatible.

Now, Therefore, Be it Resolved that a 1.0 FTE LTE Emergency Preparedness Coordinator position is deleted from the permanent salary detail of the Public Health 2008 Operation Budget, and the LTE Community Relations Specialist is increased from half-time to full-time status.
