1. CALL TO ORDER (Chairperson Ted Crabb)

Chairperson Ted Crabb called the meeting to order at 5:30 PM.

2. PUBLIC COMMENT

No one registered to speak.

3. APPROVAL OF MINUTES (DCC Minutes of 6-21-07)

A motion was made by Zellers, seconded by Judge, to Approve the Minutes. The motion passed by acclamation.

4. NEW BUSINESS

A. Air Quality (Brett Hulsey)

- -Brett Hulsey, President, Better Environmental Solutions gave the DCC
- Committee a laptop Power Point presentation on the following:
- -Air in Madison is generally pretty good.
- -3 basic types of air pollution: smog, soot, haze.
- -Right now Madison complies with federal health standards.
- -Ozone levels here are stable.
- -97% of our air comes from outside Dane County.
- -Asthma rates are down in schools since 2003.
- -About 70% of hazardous air pollution in downtown Madison comes from trucks and buses.
- -About 30% of air pollution comes from gas stations, dry cleaners, fast food restaurants, and bakeries.
- -Power plants produce less than 1% of air pollution.
- -Diesel pollution causes pre-mature births, heart attacks, and strokes.
- -A Denver study showed that people who live near roadways with more than 20,000 vehicles per day were 6-8 times more likely to have leukemia and other cancers.
- -During the 1996 Olympics in Atlanta, an effort was made to cut automobile traffic and encourage the use of mass transit. During this period, asthma attacks were cut by 22%, even though "dirty air" buses were used.

- -Exercising along a busy traffic route is like smoking a pack of cigarettes a day.
- -Suggested solutions to clean up the air:
- 1) Clean up all diesel trucks, buses, and construction equipment.
- 2) Pass anti-idling ordinances for diesel engines.
- 3) Require vent controls on all gas stations.
- 4) Step up energy efficiency and renewable purchases.
- -Information on grants to improve pollution of trucks, buses, and construction vehicles is available at: www.cleandiesel.gov.
- -If the air quality gets to bad, the federal government can withhold issuing any more building permits.
- -Bio diesel is a cleaner fuel for trucks and buses.
- -The circulation of bad and dirty air circulates down the Ohio river valley, then up the Mississippi river valley to over Lake Michigan where the smog heats up over the lake due to the reflection off of Lake Michigan. Because of this circulation air pattern, the air in Door County is worse than in Chicago.
- -The airline industry is also trying to burn cleaner fuel.
- -John Harrod, Director of UW Physical Plant, said that the Charter Street Heating Plant is undergoing a study to review economics, environmental impact, most efficient means of producing energy. Town hall type meetings will be planned and held in the future.
- -Burlington, VT burns 68% renewable energy.
- -City of Madison has wood, and Dane County has grasses which could be used as bio-mass and bio-fuel.
- -Bio-mass can be hauled from within 50 miles, vs. shipping in coal to Wisconsin from West Virginia and Wyoming.
- -No homes should be built or located within 200 yards of the Interstate due to air quality concerns.
- B. Capitol Square Mall/Concourse Grounds Maintenance (Jim Weinstock)
 - -The question was raised as to why the landscaping on the State side of the square looks better than the city side?
 - -State side has less compacted grass, better irrigation system, less walking access on the grass, and greater flexibility on use of herbicide.
 - -Weinstock thinks the maintenance crew and parks staff could do a better job, but it will never look like a golf course. Weinstock said that he will contact the staffs at the City Golf Courses and Olbrich Gardens to see what suggestions they might have for improved maintenance and plantings.
 - -Lang Sollinger suggested prairie plantings on the Pinckney St. side of the square, due to the lack of a high water table in that area. She said there are large trees on Carroll St. because of a higher water table.
 - -Carbine said it is important to make sure that things look good downtown for safety, business and economic development. Carbine also suggested starting a volunteer group to help with planting and maintenance. Many people who move into condos are still looking for ways to use their green thumbs.
 - -Weinstock will continue to push for an increase in staffing in the downtown area.
