The above-named complaining witness being first duly sworn states the following:

Count 1: RESISTING AN OFFICER

The above-named defendant on or about Sunday, May 25, 2008, in the City of Madison, Dane County, Wisconsin, did knowingly resist Madison Police Department Police Officer Brian Chaney, while such officer was doing an act in an official capacity and with lawful authority, to wit: attempting to detain a subject, contrary to sec. 946.41(1), 939.51(3)(a) Wis. Stats., a Class A Misdemeanor, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

FACTS:

Your complainant is a court officer/detective with the City of Madison Police Department, and for this complaint, is relying on the written report of City of Madison Police Officer Brian Chaney.

Officer Chaney reports, on May 25, 2008, he was dispatched to back up the parking enforcement officer, in the 400 block of North Frances Street, in the City of Madison, Dane County, Wisconsin, regarding a scofflaw violation, towing a truck. Officer Chaney reports that he was on duty and wearing the full Madison Police Department military style uniform. Officer Chaney reports he assisted parking enforcement officer, Dominic Stephenson, in towing a black pickup truck parked on the street. Officer Chaney reports that, while the vehicle was being towed, he observed an individual, later identified as Jeffrey Okafo, walk up to Stephenson quickly and stand in his face, yelling at him. Officer Chaney reports he abruptly contacted Okafo and identified himself as a police officer to him. Officer Chaney

reports that Okafo did not comply with several of his commands to place his hands behind his back, and based on his training and experience, Officer Chaney believed Okafo was meaning to cause Stephenson and Officer Chaney harm. Officer Chaney reports Okafo screamed, "I'm going to fuck you up," at which point Officer Chaney deployed a taser. Officer Chaney reports Okafo ripped out the taser probes from his chest, at which point Officer Chaney then deployed his OC spray. Officer Chaney reports he continually gave Okafo clear commands to stop resisting arrest, and when he attempted to place Okafo in handcuff restraints, Okafo physically resisted. Officer Chaney reports Okafo was eventually placed into handcuffs with the assistance of supporting officers.
