II. Rules and Procedures for Public Testimony

A question was asked on how to provide help to taverns losing business. Suggestions include promoting the smoke free environment to bring more conventions into the city and bringing in a business consultant to help with a business plan. Another question was if any existing smoking ban ordinance in other municipalities had been repealed or weakened. The reply was that in the 185 cities that have restricted smoking in bars, not one has been repealed or weakened.

C Establishing an advisory referendum on Madison's Smoking Ban.

The Board of Health for Madison and Dane County moved to support the current smoking ban ordinance and recommend to Common Council to reject this proposed resolution.

V. Discussion and Action on Smoking Proposals

Board members prefer not to see the current smoking ban weakened, as it is the responsibility of the Board of Health to make recommendations that protect the health and safety of citizens. While there was no consensus to support a hardship exemption, the effect that this change is having on businesses and employees was acknowledged by some Board members. Others felt a hardship exemption could defeat the purpose of the ordinance and that it creates an uneven business environment. It was noted that is appears mostly bars in the periphery of the city are being affected. The future probably is adoption of similar ordinances in the rest of Wisconsin, including surrounding communities, and from a public health perspective this is something the Board actively favors.

Motion by Zahner/Sonzogni that the Board of Health for Madison and Dane County support the current smoking ban ordinance and recommend to Common Council to reject these proposed ordinances and resolution.

Motion by Zahner/Sonzogni that the Board of Health for Madison and Dane County encourages the Dane County Board of Supervisors and governing bodies of all incorporated municipalities in Dane County to pass ordinances similar to that passed in Madison banning smoking in places of employment.
