After a year of decreases, enrollment and capacity again has again increased. . There was again a drop in enrollment under Wisconsin Shares- part of which may be due to low income families using Madison’s relatively new 4K program. The number of children in high quality accredited programs increased, probably due to the new YoungStar program. The above chart does not include public school kindergarten enrollment, pre-kindergarten at risk programs or on school site public school 4 year old kindergarten programs. A chart covering unlicensed public and private school programs for children under age six is on page 2 of this report.

There was also an increase in school age program enrollment – it seems due to several existing sports and arts focused school age programs becoming regulated. **Overall there is an estimated 1800 empty slots in regulated family child care, full day group centers and school age programs in Dane County.** While a large number, it is less than last year.

Part day preschools saw an increase leaving only Family child care with a decline this year continuing recent trends. Almost all of the losses were in certified and provisional family child care. Hopefully this will improve if child care subsidy rates improve next year. Overall child care enrollment indicates that Dane County is coming out of the recession. Cost was a major deterrent to using regulated care indicated by parents in a small 4-C study in 2012 though the study also indicated that millennial parents wanted to spend more time with their children and thus use child care less.

In this report there will be some minor variations in terms of total enrollments between some of the different geographic charts involving the City of Madison. This is usually due to the fact that census tracts and neighborhood planning areas vary and often include areas outside the city. In some cases the data can be limited to just the city of Madison and in others the data cannot. Throughout this report there will be references to the new YoungStar rating system for child care and early childhood education programs including an analysis of the number of programs at the various quality rating levels in each zip code in Dane County. .An explanation of YoungStar is on page \_\_\_

## Public School Programs in Dane County for Children under Age Six 2013-2014

Public Schools in Dane County increasingly are providing additional programs for children under age 6. These include: pre-kindergarten programming for children at risk (listed on the chart as pre-k); regular kindergarten for children age 5, usually offered in a full day format; and 4 year old kindergarten (4K). There are also private schools offering both 4K and kindergarten which are exempt from state licensing.

4 year old kindergarten (4K) is offered now by all but one school district in Dane County. 4K is usually offered as a part day program. The models for it vary from district to district. Depending on the district locations, it can be either in the local public schools or by subcontract in various state licensed child care, preschools or head start programs. The arrangements for the latter vary from district to district. Quite often the district provides the state certified teachers but in some situations the state certified teacher is on the staff of the center.

The data in the following chart is taken from the 2013-2014 public and private school annual enrollment report on the Wisconsin Department of Instruction Website. It is presented by school district not municipality. 4k data is presented in total for each district but also split between in public school and in licensed programs categories. The 4k enrollment data for state licensed programs should be included as part of the preschool numbers in the other charts within this report. The in school 4k data, the Kindergarten and pre-K numbers represent children in programs but which are not included in the other charts in this paper which are limited to state regulated programs outside the public schools. If you add in the public school preschool numbers to the total in regulated care there are 14,587 children in some type of preschool program in Dane County (and that does not include 5,678 five year olds in regular kindergarten). These figures need to be considered when planning additional preschool care or early childhood programs.

The Madison School District includes some areas outside the City of Madison. Programs outside school buildings were assigned to the nearest school attendance area unless enrollment was identified to a particular school. This covers only regulated programs providing care for children after school. ## The YoungStar Child Care Rating System

The State of Wisconsin is implementing a rating system for child care, early childhood education and school age programs. The system is based on programs attaining one to 5 stars. The following page briefly explains how programs obtain the various stars in the ratings.

### Reading the Stars: Understanding the 5-Star Quality Rating and Improvement System

#### How Can YoungStar Help Parents and Families Choose Quality Child Care?

Making an informed choice about who will care for our children while we are working is one of the most difficult and important decisions a family can make. YoungStar is a five-star quality rating and improvement system that supports families in making this decision. The rating-scale recognizes practices that early learning settings have in place that are proven to be good for kids. YoungStar gives families a snapshot of a program's quality to compare with their own views on quality child care. Programs can be meeting quality standards to some degree at 2, 3, 4, and 5 stars. #### What Does Each Star Rating Mean?

A provider's star rating is based on these four categories of quality:

**Provider Education and Training** Children benefit when their teachers and caregivers have a solid foundation in early care and education principles and practices. YoungStar acknowledges the academic achievement of teachers/caregivers and administrators.

**Learning Environment and Curriculum** When teachers and caregivers create meaningful experiences for infants and young children, they are more likely to have long-term school success.

**Business and Professional Practices** How programs do business matters. Well-respected, fairly-compensated professionals, who are actively maintaining professional standards and business practices and engaging families, are better able to respond to meet the needs of children and their families.

**Health and Wellness** Children grow up in the context of their families, communities, and culture. These standards look at the outcomes of the whole child from nutrition and physical activity to meeting special needs and being responsive to how kids form relationships.

## How Do Providers Earn Their Star Rating?

YoungStar program staff at the local level provides on-site technical consultation and independent review and assessment to programs. Consultants review programs for evidence of meeting quality indicators related to the four quality categories.

YoungStar uses compliance with existing child care regulations as a base. For the purposes of YoungStar, programs are considered to be in regulatory compliance unless they have had their license or certification revoked, denied or suspended. With compliance intact, programs can then achieve a star level. Star levels are earned on a point scale of 0-40 with each star level having minimum requirements that must be met.

**2 Star Automated:** Program has submitted required paperwork to meet minimum state mandated requirements but in most cases has decided to bypass YoungStar quality improvement technical consulting.

**2 Star:** Program has earned 0-10 points and is actively participating in quality improvement efforts with a quality improvement technical consultant.

**3 Star:** Program has met the minimum requirements for the star level and earned 11-22 points.

**4 Star:** Program has met the minimum requirements for the star level and earned 23-32 points.

**4 Star Automated:**

Program is an accredited group or family child care that meets the 4-star educational requirements.

**5 Star:**

Program has met the minimum requirements for the star level and earned 33-40 points.

**5 Star Automated:**

Program is a group or family child care that meets national or state accreditation standards as recognized by DCF and meets the educational requirements for the 5-star level. Head Start, Early Head Start and Tribal Head Start programs that meet Head Start performance standards as verified through the triennial review process will be awarded a 5-star.

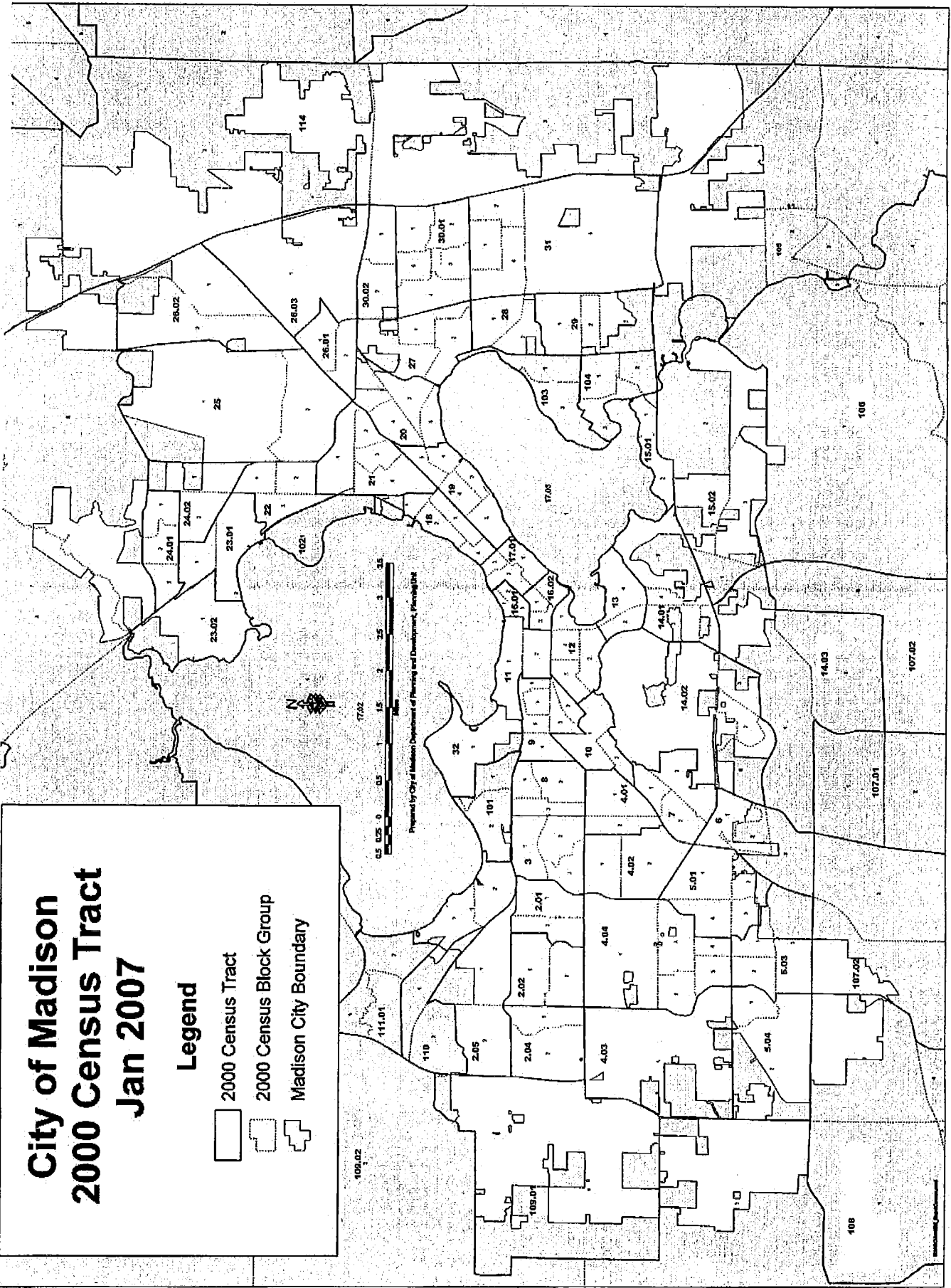
# City of Madison 2000 Census Tract Jan 2007
