4 23287 CDA EXECUTIVE DIRECTOR'S DISCUSSION

Erdman reviewed the Director's Report, covering Items 6, 6a and 7 below:

- Erdman continues to attend Neighborhood Watch meetings.
- Allied is a priority for the Neighborhood Resource Teams organized by the Mayor's Office.
- The revised plat has been approved.
- Staff is proceeding to draft RFP for home buyer education and readiness.

Erdman reviewed the draft RFP. The CDA is undertaking the development of 24 single-family homes at Mosaic Ridge and is soliciting proposals from developers/builders for services relating to the construction and sale of the homes. The proposals will be reviewed by CDA staff and scored by a scoring team comprised of CDA Commissioners, CDA staff and community representatives.

The RFP requests developer teams to bring the full package of expertise and services, i.e., construction, consortium of first mortgage lenders, realtor(s), etc., necessary to provide a one-stop shop for the buyer. Thompson-Frater noted that the team may be assembled by an individual other than a developer or builder who has worked in this area. Levitan noted that the terms used throughout the RFP should be uniform and emphasis be placed on the building/construction piece.

Home buyer education and readiness will be made available to potential buyers. Staff is in the process of drafting an RFP for these services. Also, the CDA will be offering down payment assistance for qualifying borrowers.

A pre-submittal meeting will be held. Subcommittee members requested that Terri Goldbin of Brown's staff be invited to the meeting to share information and answer questions about the City's down payment assistance programs.

The Subcommittee members expressed support for the RFP and asked Erdman to inform the CDA Commissioners that the RFP is in Legistar and an update will be provided at the October 13 Board meeting.

Thompson-Frater offered her services to work with staff in coming up with a list of names the RFP will be sent to.
