## *Proposed August Service Adjustments*

On Wednesday, April 10, Metro Transit and the City of Madison Transit and Parking Commission will hold a public hearing at 6 PM to discuss service changes proposed to go into effect in August.

Proposed service changes include the creation of a new Route 31 to the Owl Creek neighborhood. Possible adjustments to Routes 2, 5, 9, 10, 14, 15, 16, 18, 25, 28, 31, 33, 34, 38, 39, 40, 41, 44, 47, 48, 56, 57, 71, and 72 are also being considered.

Additional routes and affected areas may be included at the public hearing.

# Proposed Changes

**Route 2** – Proposed 15 minute frequency during peak hours west of the Capitol Square.

**Route 5** – Schedule adjustment to better coordinate service with Routes 16 and 40 during nights and weekends.

**Routes 9 and 10** – Updated route designs. Service shifted west to address overcrowding along University and Sheboygan avenues. Route 9 no longer serves East Transfer Point or Route 33.

**Route 14** – Realignment of service. No longer travels on Sheboygan Ave. Improved connections at East Transfer Point. Offset from route 15 schedule to provide 15 minute frequency at East Transfer Point during peak commute times.

**Route 15** – Realignment of service. No longer travels on Sheboygan Ave in commute direction. Expansion of service to Grandview Commons, east of I-90. Offset by 15 minutes from route 14 at East Transfer Point during peak periods. Reduction of frequency in area south of Cottage Grove Rd.

**Route 16** – Schedule adjustment to better coordinate service with Routes 5 and 40 at the South Transfer Point, and with Route 31 at the East Transfer Point, during nights and weekends.

**Route 18** – All buses travel via Allied Dr. and Chalet Gardens between 6:00 AM and 7:00 PM. Service eliminated on Crescent and Red Arrow. Buses will not serve the “Coho Loop” until 7:00 PM on weeknights (replaced by Route 40 “via Coho” service).

**Route 25** – Eliminate 7:55 AM trip from Main and Carroll and 5:07 PM trip from the American Family Office Park.

**Route 28** – Eliminate the Sherman Via. All trips operate on Fordem Ave.

**Route 31** – New service between East Transfer Point, Lafollette and Owl Creek neighborhood.

**Route 33** – Eliminate route.

**Route 34** – Reduction to hourly frequency during peak hours (scheduled to meet MATC class times).

**Route 38** – Improved scheduling of extra trips (shaded gray in Ride Guide). All AM trips travel via Wilson St.

**Route 39** – Trips reduced. Service will be reallocated to Route 31.

**Route 40** – “Via Coho and Greenway” route to operate in place of service on Route 18. Trips will alternate with existing route 40 until 7:00 PM. This via will travel via Todd Dr, Coho, and Greenway. Weeknight schedule revised to better coordinate with Routes 5 and 16.

**Routes 56 and 57** – Adjustments south of West Transfer Point and around Capitol Square.

**Routes 71 and 72** – Due to overcrowding along University Ave, routes are proposed to become limited stop in Madison.
