Dear Parks Commissioners,

Once again you are being asked to allow the Madison Mallards to include fireworks displays in their post-game entertainment for 2025 and (with no further review!) 2026, as a sort of quid pro quo for the "benefits" their organization provides to the Northside. By now Big Top Entertainment's self-serving reasons for requesting these displays, and the many reasons they are harmful, should be clear. A quick Google search will provide ample evidence of fireworks' harmful effects. NO decibel level is safe for wildlife, especially juveniles in their nests. NO level of pollution is safe for air, soil, and groundwater. Neighbors, especially refugees and those who suffer from PTSD, should not be asked to tolerate ANY displays of light and noise for the entertainment of a small number of fans and the enrichment of a private corporation. It's especially ironic that these take place in a public park, nominally a space where visitors can relax in the quiet enjoyment of nature and a vital refuge where residents can live and raise their families in safety. *Fifty-seven years ago* the Parks Commission removed fireworks from Vilas Park because of their harmful effects on the zoo

animals. Approving the Mallards' requests for this year and next can hardly be considered progress. It's past time to question the assumptions that fireworks are an obligatory conclusion to sporting events, that the entertainment and profits they provide justify the harm they cause, and that no other options are available. It's past time for the Parks Commission and the Common Council to think very hard about whose interests they should be safeguarding. Please require them to drastically reduce dB levels of all future displays, phase them out over the next two years, and replace them with post-game entertainment that can peacefully coexist with their human and animal neighbors and the natural environment of which they are privileged to be a part.

Afternoon,

I am writing to express my concerns about the proposal to increase the number of fireworks shows at the Madison Mallards ballpark in Warner Park. While I understand that these events are popular and generate revenue for the community, I believe it's important to also consider the significant distress they can cause for nearby residents and their pets.

As someone who lives close to the park, I witness firsthand the impact these events have on my golden retriever. Normally a happy and lovable companion, he becomes a quivering mess during fireworks, trembling and hiding until the noise stops. This is not just anecdotal; studies have documented the acute stress that loud and sudden noises cause in domestic animals. For example, Carrieri-Rocha et al. (2020) found that dogs living near noisy environments, such as football stadiums, exhibited severe anxiety behaviors, including trembling, appetite loss, and attempts to flee. The proximity and unpredictability of fireworks only amplify these effects.

Beyond pets, fireworks also adversely impact individuals with PTSD. Research has shown that sudden loud noises can trigger a startle response, hypervigilance, and even flashbacks in those affected. For example, Shalev et al. (2000) demonstrated that trauma survivors with PTSD experience heightened physiological responses to loud tones. Similarly, Glad et al. (2016) reported that auditory reminders, like sudden and sharp noises, are frequently distressing for PTSD sufferers. These findings highlight how fireworks can unintentionally harm some of the most vulnerable members of our community.

While I recognize that for many people fireworks are a highlight of summer, I feel compelled to ask:

- What is the acceptable ratio of people enjoying themselves to one distressed individual, whether it's a pet owner, someone with PTSD, or a child with sensory sensitivities?
- How do we weigh the economic benefits of these events against the emotional and physical toll they take on vulnerable members of our community?

These questions are not meant to diminish the value of fireworks but to encourage thoughtful consideration of their broader impact. Many cities have begun exploring alternatives, such as silent fireworks or drone light shows, which preserve the celebratory spirit while minimizing harm. A study by Bateman et al. (2023) advocates for these alternatives, highlighting their effectiveness in reducing stress on pets and local wildlife.

I respectfully urge you to oppose increasing the number of fireworks shows at Warner Park and to advocate for more inclusive and sustainable solutions. Thank you for your time and attention to this matter. I would welcome the opportunity to discuss my concerns further.



This is another reason to reconsider the fireworks' and it's implications on the health and well being of the creatures that live in Warner Park.

Fireworks are also very bad for bats. When we lived in Madison, Warner Park had four bat species. Bat species are crashing in the US, with most bats losing 90% of their populations to White Nose Syndrome. Wisconsin wildlife experts who studied Warner's bats told Wild Warner we had a healthy bat population in 2013, with pregnant bats and a probable roost in the park, which is unusual. But they also told us that fireworks were terrible because bats have extremely sensitive ears. Some bats can live 25 to 35 years. Like birds, they are loyal to their breeding grounds. Warner Park is or was their home. I'd like to know what has happened to Warner's bats with the increase in Mallard fireworks. Bats eat trillions of mosquitoes and other pests. And according to a study published in the prestigious journal Science just one month ago, when bat populations decline, farmers increase pesticide use by as much as 31%. Scientists discovered that when farmers increase pesticide use--infant mortality rates go upby as much as 8%. Because babies are very sensitive to traces of pesticides. The researchers concluded that bats save human babies (see Bats: Surprising New Research Links Infant Mortality to Crashing Bat Populations).



Without bats to eat insects, farmers turned to more pesticides, a study found. That appears to have increased in...

Has this has been studied in Madison? What has happened to the Warner bat population since that DNR survey in 2013? How will an increase in the Mallards' fireworks affect them? And how does infant mortality in the Warner Park area compare to other Madison neighborhoods? Has it increased? Decreased?

Fireworks and loud noise can also cause distress in some humans, provoking a flight-or-flight panic response which floods our bodies with stress hormones. In a 2016 study of 17 airports in England, researchers concluded that "living under flight paths has a negative effect on people's overall wellbeing equivalent to around half of the effect of being a smoker for some indicators." In public health, noise pollution is becoming the new smoking. But you must also consider that this Madison neighborhood has a higher noise pollution load than anywhere in the city, not just because of the fireworks, but because it is adjacent to the airport and the F-35s. The three noise pollution factors combined represent an unacceptable environmental burden for this neighborhood.

I have seen Mallards' proposal seeking approval of City Parks for their fireworks schedule for the next two years, 2025 and 2026. I offer the following comments as an individual resident and not on behalf of any group..

BALL GAMES AT WARNER PARK DO NOT REQUIRE FIREWORKS

The Northside community had ball games in Warner Park for twenty years commencing around 1980 with the newly formed team called Madison Muskies. The community was glad to have this addition. There was zero conflict because Muskies just played ball, proving ball games could be held without fireworks. Muskies did not feel they had to generate a lot of noise-banging and thumping noises, contaminating chemicals, killing birds and other wildlife, disturbing families and individuals sensitive to excessive noise, and keeping people awake all hours.

Northsiders suffered through this for about twenty years! Then it turned out the Downtown didn't want this disruption either! So now, Mallards is back—again wanting to shoot off fireworks in Warner Park in connexion with its ball games. They inflict these atrocities on all their neighbors for half of every summer, apparently believing that the Northside can never have enough discomfort and killing of birds and wildlife if only Mallards can rake in money from admissions and lots of beer sales.

GROUP FIREWORKS EVENTS DO NOT PREVENT INDIVIDUALS FROM HAVING FIREWORKS AT THEIR HOMES

Some argue that group fireworks save people from the stress and hassle of individual fireworks around the 4^{th} . This argument doesn't hold water. On the Northside we get individuals shooting off fireworks starting several weeks before the 4^{th} , and ending up to a month afterwards.

IT IS NOT APPROPRIATE TO CHANGE PARKS' PRACTICE OF CONSIDERING FIREWORKS ONE YEAR AT A TIME

Parks has let Mallards hold these fireworks every summer for 24 years! And now, for the first time ever, Mallards have sent emails to the neighborhood associations on the Northside announcing their proposal to seek approval for their fireworks two years at a time. Mr. Stenman says they now want Parks to approve this continuing travesty for TWO MORE YEARS.

Is contacting neighbors by email every year too big a burden, given the millions of dollars Mallards makes yearly from this enterprise? Burden or not, I question whether it is even legal for the Parks Department not to provide city residents with timely public hearings each year, as has been done the last 24 years. How many baby birds will these proposed fireworks kill? How much more contamination will those fireworks leave in the grass where children play sports, and move from there into the lagoon and the lake to poison the wider community? How many neighbors will experience more pain from the noise of these fireworks? These consequences of the fireworks pose major concerns in the Northside community. I see that for this year the Mallards are proposing three lower volume displays of 85 decibels. It would be an improvement to have the July 4th display as one of the lower volume ones. We are writing in regards to the January 8, 2025 BPC agenda item #14 and #15 relating to the Madison Mallards' request for fireworks shows launched from Warner Park in 2025 and 2026. We represent the Southern Wisconsin Bird Alliance (formerly Madison Audubon), an organization that celebrates and supports birds, wildlife, and the people who care for them. We work with over 3,000 members in southern Wisconsin, many of whom reside in the Madison area.

We appreciate the Madison Mallards' proposed reduction of fireworks shows from 7 to 6 in 2025, and from 6 to 5 in 2026, and that three of each year's shows will be low-decibel shows. We are also glad that they acknowledge the nesting of Bald Eagles in close proximity to the launch site and are committed to not hosting fireworks shows until the eaglets have fledged.

However, under the proposal there remain many noise and air quality issues that result from the Mallards' numerous fireworks displays, all of which are likely to have significant impacts on wildlife and communities in and around the park. Six fireworks shows, including one longer 23-minute display, will produce excessive amounts of environmentally harmful air and soil pollutants, as well as extreme noise levels during a critical time of year when wildlife are nesting and raising young.

We urge the Board of Park Commissioners to consider these important issues in limiting the number of fireworks shows in 2025 and 2026, and require that all approved fireworks shows are low-decibel displays.
