The Dane County Zoning and Land Regulation Committee at its August 12th meeting approved the 2-lot proposed Certified Survey map and is hereby conditionally approved as follows:

1. The document is to be completed in accordance with S.236.34, Wisconsin State Statutes.
2. The following notation shall be added – *Refer to building site information contained in the Dane County Soil Survey.*
3. Remove any notations referencing adjacent zoning districts.
4. All owners of record are to be included in the owner's certificates.
 - *County records indicate that ELLEN PAMPERIN CORP is the owner.*
 - *Remove the reference to the dedication as no public dedications are shown.*
5. The required approval certificates are to be satisfied prior to final submittal.
 - *Town of Burke*
 - *City of Madison*

6. Comments from the Dane County Surveyor are to be satisfied:
- a. *Change the right-of-way lines within lots to a broken line type to graphically indicate the road is not dedicated and ownership continues to the centerline. It would also be preferred to make the boundary line of the CSM a solid line. 236.20(2)(a)*
 - b. *Indicate the diameter and type of monuments found. 236.20(2)(b)*
 - c. *Change the bearing listed in the bearing reference note to the bearing of this map for stated line. The bearing listed is the "recorded as" bearing for the line. 236.20(2)(i)*
 - d. *Remove the word "dedicated" from the Owner's Certificate, as no dedications are present. 236.34(1)(e)*
7. The recordable document is to be submitted for review and approval.

When the above conditions have been fully satisfied, the original document along with a copy of this letter may be submitted for final review and the Dane County approving signature will be affixed. Please allow for ten (10) working days for approving signature. Any questions regarding this letter, please contact myself.

WHEREAS, the Plan Commission has reviewed the CSM and recommended conditional approval of the CSM; and


WHEREAS, the Town Board has reviewed and considered the Plan Commission's recommendation.
