Landmarks Commission Members:

Thank you for your work in considering the proposed land division request by the LLC which recently purchased the house at 1908 Arlington Place in University Heights.

My husband, Attorney Lester Pines, who lives with me at 1915 Arlington Place, has already written you two times on behalf of both of us in opposition to the land division proposal and he will testify at tonight's meeting on behalf of both of us on content matters related to the land division request before you.

I write here not to address related content issues, but rather to address two process points related to the matter:

- 1. Unfortunately, the mailed notice regarding the matter and public hearing came out not long ago in the midst of the busy holiday and school break season, with many impacted neighbors and interested others out of town with family, and, in fact, out of the country, as some still are, making writing in or zooming in from remote locations without internet service difficult. This important historic preservation matter has significance not only for neighbors, but for many others beyond and should not be considered within a rushed timeline.
- 2. In spite of the challenges noted above, numerous written submissions opposed to the land division have been sent to you already:
- -at least 7 communications opposed to the land division had already come in as of earlier today, representing 2 people each (two of these senders wrote 2 times with follow-up information) = written expressions of opposition to the proposal representing 14 individuals
- -at least 7 communications opposed to the land division had already come in as of earlier today from 7 individuals

-Therefore, the above reflects written statements of opposition submitted by earlier today from at least 21 individuals including those who are lawyers, architects, appraisal experts, historic preservation leaders and more from the neighborhood and beyond.

Only two individuals had written in supporting the proposed land division as of earlier today.

I hope you will take this information into account as you consider ANY possible votes or actions on this matter today.

I was one of the members of the Regent Neighborhood who was on the Landmarks Commission Zoom tonight. Regardless of the outcome of the Arlington Place decision, I was very sorry to hear that very few of the Commission members addressed the frustrations of the vast majority of those present, those who were in opposition of the lot division. The written submissions from both sides of the issue were well researched and quite eloquent. I couldn't help but trip over the questions at the top of your agenda:

Consider: Who benefits? Who is burdened? Who does not have a voice at the table? How can policymakers mitigate unintended consequences?

One commission member asked for a photograph of the property in question. There was none to be had. Few of the members likely visited the site. We're all busy. I understand there are written laws, ordinances, and guidelines that you're adhering to. But, why bother with the human element at all, in the form of public comment, when so few of the comments were addressed? People build neighborhoods and cities, not just words on pages. Again, I understand the outcome would not have been different, but I urge you and your commission members to address the real concerns of the citizens who make up this neighborhood who have a day-to-day, year-to-year concerns and physical and emotional experiences with this place in particular, and other places that come before you, in general.
