As a long-time resident living two blocks away from this location, I would like you to understand my concerns about a proposed drive-through at 7202 Mineral Point Road. This item is on the agenda for your April 20th meeting.

1. I am greatly concerned about the additional vehicle traffic that will be generated in this block between Gammon Road and Westfield. If approved, this restaurant would be the only drive-through facility that has direct access to and from a major artery in this area. All of the neighboring "grab and go" restaurants are accessed from within a larger parking lot or from a secondary street...Chick-Fil-A, Jason's Deli, McDonald's, Starbuck's.

Increasing the traffic entering and leaving this location will do nothing to reduce accidents on this section of Mineral Point Road. To the east, the Mineral Point/Gammon intersection consistently ranks as one of the most dangerous intersections in the city. To the west, the intersection of Mineral Point Road and Westfield is already a challenge.

When traveling west on Mineral Point Road, many drivers are usurping the bus/bike/turn lane as a third lane of traffic, especially during the after-school and evening commute hours. Additional vehicles entering and leaving the road will make this block more dangerous.

2. The increased traffic from a drive-through will negatively impact the atmosphere of the area. The current mix of businesses provides a sense of community and neighborhood identity for residents living north of the 7200 block. The area offers services that are regularly used by the residents...banking, healthcare, and a restaurant. These are destinations that are used by me and many of my neighbors. Often accessed on foot, the businesses strengthen the identity of the neighborhood by providing opportunities to interact socially. This will be lost with the addition of a drive-through in the center of the block.

To the Honorable Alderman Paul Skidmore,

I am writing to oppose the construction of a Culver's at the location of the current Old Chicago on Mineral Point Road. I approach this from being a fan of both companies. But ultimately, it stems from my concerns with the traffic surrounding West Towne Mall, especially on Mineral Point Road.

The traffic on Mineral Point Road is already dense, especially around rush hour. The egress directly onto Mineral Point Road is especially challenging, since drivers can only turn right. Those that want to go east on Mineral Point may be confused.

Another concern is related to cycling. There is currently a cycling lane on the right. Many drivers do not pay attention to cyclists, even in Madison. Inattentive drivers turning west on Mineral Point may hit cyclists and pedestrians.

Finally, Old Chicago in Madison, despite being a national chain, has actually become a social and cultural location for a number of people to get together. The restaurant attracts families, employees, and neighbors. I personally have made a number of friends while visiting the restaurant. My friends range from coaches, IT employees, nurses, pharmacists, radio disc jockeys, meteorologists, accountants, cyclists, attorneys, and musicians. Without such a venue, I probably wouldn't have met so many great people. Old Chicago on Mineral Point Rd serves as a neighborhood bar, providing so many people a chance to interact with each other and grow this community. Based on my experience with dining at Culver's, I don't see the same thing occurring.

Unfortunately, I will not be able to attend the Plan Commission meeting on Monday, April 20. However, I would appreciate if you take this letter into consideration before that hearing as my opposition to the plan to construct a Culver's at that location.
