1. - 2. Subsection (3) of Section 12.141 entitled "Penalties for Violating Sections 12.122 Through 12.140" of the Madison General Ordinances is amended to read as follows:
- "(3) Any person violating Sections 12.128(4)(a) or $\underline{12.128(6)}$ or $\underline{12.128(9)}$ or $\underline{12.128(10)}$ or 12.128(11) or 12.129(1) or 12.138 shall be subject to a forfeiture of not less than twenty-five dollars (\$25) nor more than two hundred dollars (\$200)."
- 3. Subdivision (b) entitled "City of Madison Parking Citations" of Subsection (1) of Section 12.154 entitled "Bail in Violation Cases" of the Madison General Ordinances is amended to read as follows:
- "(b) <u>City of Madison Parking Citations.</u> Whenever an accused is issued a City of Madison Parking Citation for a non-moving violation of any provision of this chapter the bail amount for that violation shall be determined as follows:
 - 4. For a violation of an ordinance adopted in strict conformity with Secs. 346.51 through 346.55, Wis. Stats., the bail amount shall be as set forth in the Revised Uniform State Traffic Deposit Schedule as adopted by the Wisconsin Judicial Conference pursuant to Sec. 345.26(2)(a), Wis. Stats., for the adopted state statute alleged to have been violated, unless the Common Council has specifically established a different bail deposit amount under (1)(b)2. below.
 - 2. For all violations not covered under (1)(b)1. above and for those violations covered by (1)(b)1. but for which the Common Council has determined that a different bail deposit amount is appropriate, the bail deposit amounts shall be those set forth in Sec. 1.08(3)(a) of the Madison General Ordinances and enacted in accordance with Sec. 800.03. Wis. Stats."
