Meg,
This is a more complicated question than them realize.
Single men, single women and families with children all have different time limits based on the shelter that serves them. Families with children have a lifetime 90 day limit for those persons that receive Dane County funding. These families who are affected by the time limit can go to The Road Home shelter which does not received Dane County funding for shelter operations. There is also a warming shelter for families (minimal night-time-only accommodations) that accepts persons who have exceeded the limit. I will ask The Salvation Army if they have any data on this.
The men's drop-in shelter has a 45 day limit per year with the year starting November 1st. However, in very cold weather (I believe that temperature or wind chill at 20 degrees, men are not turned away if they have reached their 45 day limit. The women's drop-in shelter also has a 45 or 60 day limit I believe. I don't believe this is a lifetime limit.
