		Witzel-Behl reported that the number of voters on November 6, 2012 was a new record. In-office absentee voting also occurred at a record pace. The many volunteers assisting Clerk's Office staff allowed the absentee process to work. There were no complaints received about the new polling locations.
2.	<u>28492</u>	Updating the State Voter Registration System with changes to polling locations
		City Clerk Witzel-Behl indicated that the Mayor's office would like to see the Gates of Heaven polling place at 302 E Gorham changed to an accessible location in ward 46. This would need Common Council approval. Steep stairs to the basement restrooms prevent accessibility for both voters and election officials.
		Garner reported that six voters who had registered in advance were not found in the poll books for ward 41. Witzel-Behl responded that she would like to track voters in similar situations in the next two elections in order to try to identify patterns.
