**A motion was made by Michelle Dunphy, seconded by Rebecca to approve staff recommendations with exception of the Latino Academy of Workforce Development and Urban League's Construction Employment Initiative.**

**Motion was withdrawn.**

**A motion was made by Bridget Rogers to assign Urban League of Greater Madison's Construction Employment Initiative \$170,000. No seconder for the motion.**

**A motion was made by Michelle Dunphy, seconded by Consuelo Lopez to assign Urban League of Greater Madison, Construction Employment Initiative \$45,000.**

**Motion was withdrawn.**

**Shiva stated that she will abstain from the whole funding slate.**

**A motion was made by Michelle Dunphy, seconded by Rebecca Murray to approve staff recommendations.**

**An amendment was moved by Michelle Dunphy, seconded by Consuelo to reduce all youth program funding, except Wanda Fullmore by 5% and apply that funding to Urban League of Greater Madison's Construction Employment Initiative. Motion failed by the following vote:**
