Madison Planning Districts:

Planning districts are delineated by the City of Madison Planning and Development Office. They are designed to provide data at a useful scale with full coverage of the city. Their boundaries were originally derived from census tract boundaries and they generally include portions of several neighborhoods and alder districts.

The Madison Neighborhood Indicators project seeks to quantify the diverse and changing social conditions in Madison neighborhoods. The project staff has endeavored to provide up to date measures each year, bringing together data from a variety of sources and compiling them into a suite of variables used to generate neighborhood level profile reports.

To provide a demographic context to the year-to-year indicator data, a population profile sourced from U.S. decennial censuses of 2000 and 2010 is shown directly below. The annually updated indicators are shown on page two of the profile. Definitions for Census and 2012 indicator items can be found on pages three through six.

This means there was a count of five or fewer in the category shown or five or fewer in the counterpart of the category shown, the latter being derivable from the percentage. Correspondence between some neighborhood associations and planning district geographies required suppression of these data for neighborhood geographies.
