Schlenker introduced five new staff; Mark Mathwig, Emergency Preparedness Coordinator, Zulma Franco, WIC Health Aide, Karri Bartlett, WIC Supervisor, Jeff Lafferty Environmental Epidemiologist, Janel Heinrich, Director of Family and Community Health. The 2009 Public Health budget was approved by both City Common Council and the County Board of Supervisors. They approved the same budget in each legislative body. The first joint meeting of the City Board of Estimates and County Personnel and Finance Committee was held. All programs and staff continue and the proposed cuts were reinstated. The department lost two half time positions, one clerical and the Fit City Coordinator. The Fit City staff person, Kathy Andrusz, will move to a chronic disease role. The two changes in the budget are the Lab is funded jointly and the Dane County Humane Society contract is part of our budget. Agreement between Dane County Administration and AFSCME has been approved by the membership, which means that all represented who want to can transition from City employment to County employment in 2009.

6. Environmental Health Division - Tommye Schneider - 5 minutes

The negotiated lease for space at 2701 International Lane has taken place. The next step is to work on the space plan. Since the lease beings in January, she hopes the move happens early in January. The hire for another Animal Services position will soon take place. Now that the Environmental Epidemiologist has been hired, his primary duty will be the 2009 version of the environmental health report card to cover 2007 and 2008. Schwartzstein commended Schneider regarding a LaCrosse Board member inquiring about the Madison smoking ban effect on bar closings.

7. Population Health Divison - Patricia Frazak - 5 minutes

Frazak mentioned another hire in her division, Debbi Chase, Dental Hygienist. She will be filling several other positions including a Bilingual Health Aide and a Dietetic Specialist. There was another successful annual Halloween Sealant Day that took place on October 31.

8. Family and Community Health Division - Janel Heinrich - 5 minutes

Heinrich took the opportunity to introduce herself to the Board. Her sections include WIC, perinatal and family health academic linkages, health promotion, chronic disease and community/neighborhood nursing, community health assessment and maternal child health epidemiology. Frazak supervises intake, communicable disease intake, refugee, oral and child health.

OLD BUSINESS - 5 minutes

15. 2009 Budget

Caes highlighted two items in the adoption of the budget. There was the amount of \$100,000 included for transition costs to move AFSCME staff from city to county employment. The next phase will be the unrepresented staff, which depends on funds left from the AFSCME staff transition. The department realized a surplus of \$263,000, which in previous years reverted to the general fund but this year is applied as revenue to next year. As a result, is depresses the amount of GPR and affects the following years budget. Schlenker reminded the Board of the inefficient budget process the department needs to go through and he has requested the Mayor and County Executive to form a committee of the City and County comptroller, David Caes and one other person. He wants the committee to reform/reorganize the annual budgeting process in time for the next budget. He distributed a list of inefficiencies that the Board requested from the department. The suggestion was made that the Board recognize everyone involved in this budget process for their hard work and doing such a great job.

It seems this is a good solution to use for transitioning the Sanitarians to county employment. This will be used for salary purposes only, not to increase hours.
