Dear Sharon:

Pursuant to the provisions of Sec. 28.12(9)(g) of the Madison General Ordinances of the City of Madison and Sec. 62.23(7)(d)2m of the Wisconsin Statutes, I am submitting petitions against the proposed rezoning of 702 N. Midvale Blvd., which is currently zoned PUD-GDP-SIP and is proposed to be zoned to Amended PUD-GDP-SIP.

In support of said protest, I am submitting the following petitions:

1. The first set of petitions is signed by **owners** of land directly opposite the area to be rezoned extending 100 feet from the street frontage of such opposite land. Said petitions contain 37 signatures.
2. The second set of petitions are signed by **registered electors** residing within a building(s), any part of which is on land directly opposite the area to be rezoned and extending 100 feet from the street frontage of the opposite land. Said petitions contain 193 signatures.

These petitions are submitted in opposition to a rezoning of 702 N. Midvale Blvd. that will be considered by the Common Council on May 2, 2006. I would appreciate it, therefore, if you and the appropriate City staff determine whether the signatures procured for the petition(s) represent a sufficient number of signatures to require the proposed zoning ordinance to be passed by three-fourths (3/4) of the members of the Common Council.
