Child Care Assistance

Child Care Assistance funding can be used to assist families in paying for child care:

- While they work
- While they look for employment
- While they attend training or school
- Due to a special circumstance within the family (domestic violence, adult with a disability, etc.)

Eligibility Requirements

- City of Madison resident for at least 6 months
- Must be ineligible for the Wisconsin Shares Child Care Subsidy Program
- Adjusted gross income must be at least 185% of the Federal Poverty Limit
- Have a need due to employment search, employment or education/training
- Must use a City-accredited child care center or Satellite-accredited family child care home

Income Eligibility Threshold: 185% FPL

Family shares are implemented on a sliding scale with higher incomes contributing more to cost of care (typically to ~300% FPL).

Note: If the client's gross family income is below these guidelines, they may qualify for the Wisconsin Shares Child Care Subsidy. They can apply online at: <https://access.wisconsin.gov>.

Documents Required for Eligibility



- Work schedule
- Income verification
- Deduction verification
- Verification of school enrollment

Calculating Family Share

- Monthly gross income is taken, including FoodShare.
- Health insurance premiums are deducted.
- Income threshold at 185% FPL is subtracted.
- Remaining cost is the Family Share.

Example for a Family of Four:

Gross Weekly Income	\$966
Less Insurance Premium	- \$14
Adjusted Gross Weekly Income	\$952
Less weekly 185% FPL	-\$865
<i>Family Share</i>	<i>\$87</i>

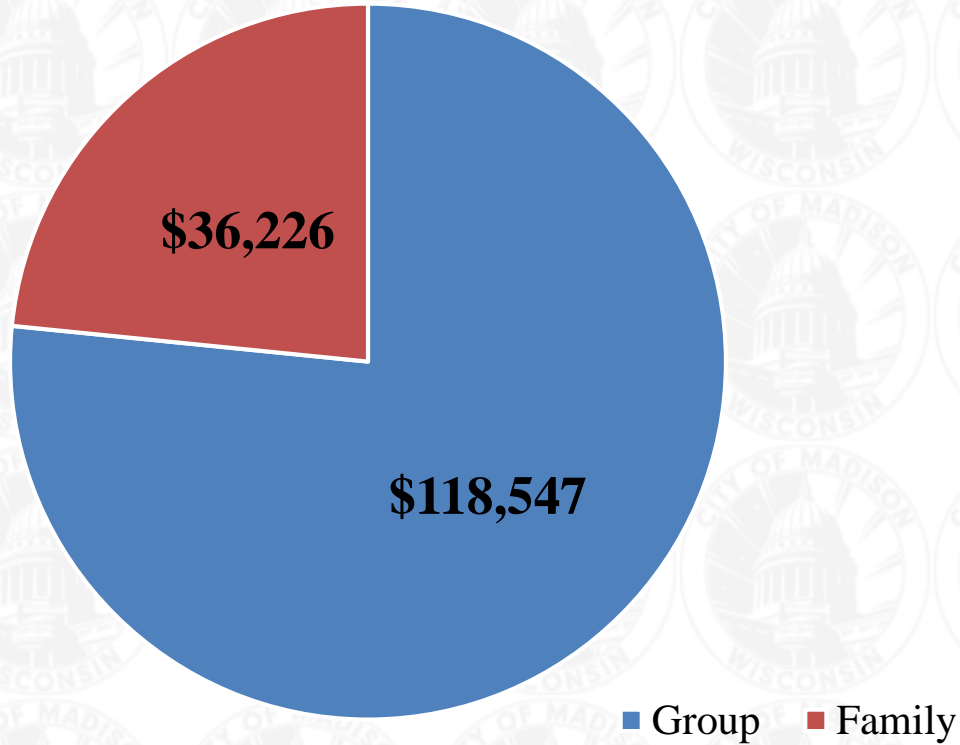
Notice

- After a family share is calculated, the parent chooses an accredited child care provider in Madison.

- The family and the provider receive notice that gives them information about the child being authorized and the amount of child care assistance that the city will provide for the care of that child (hours and funding level).

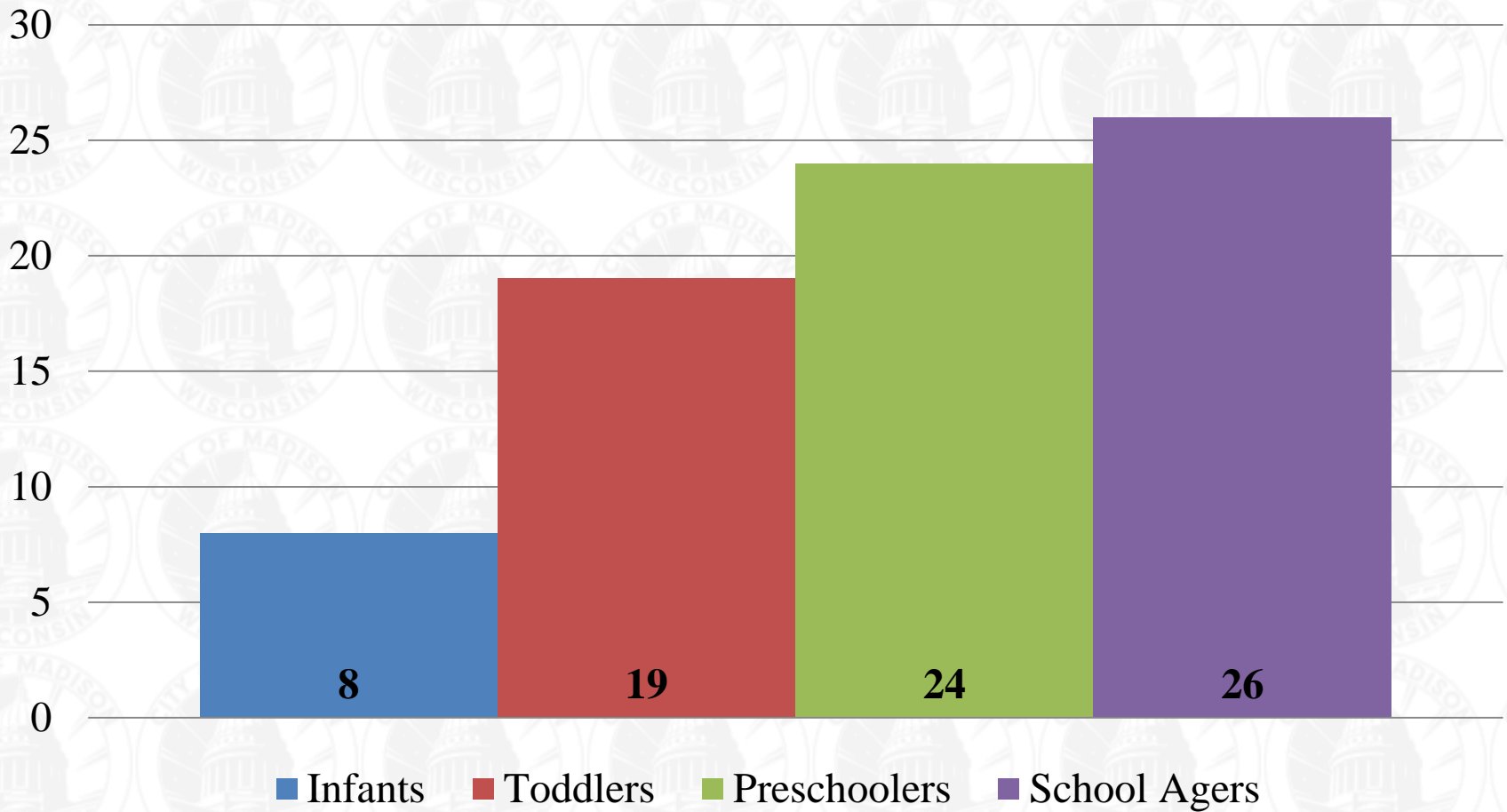

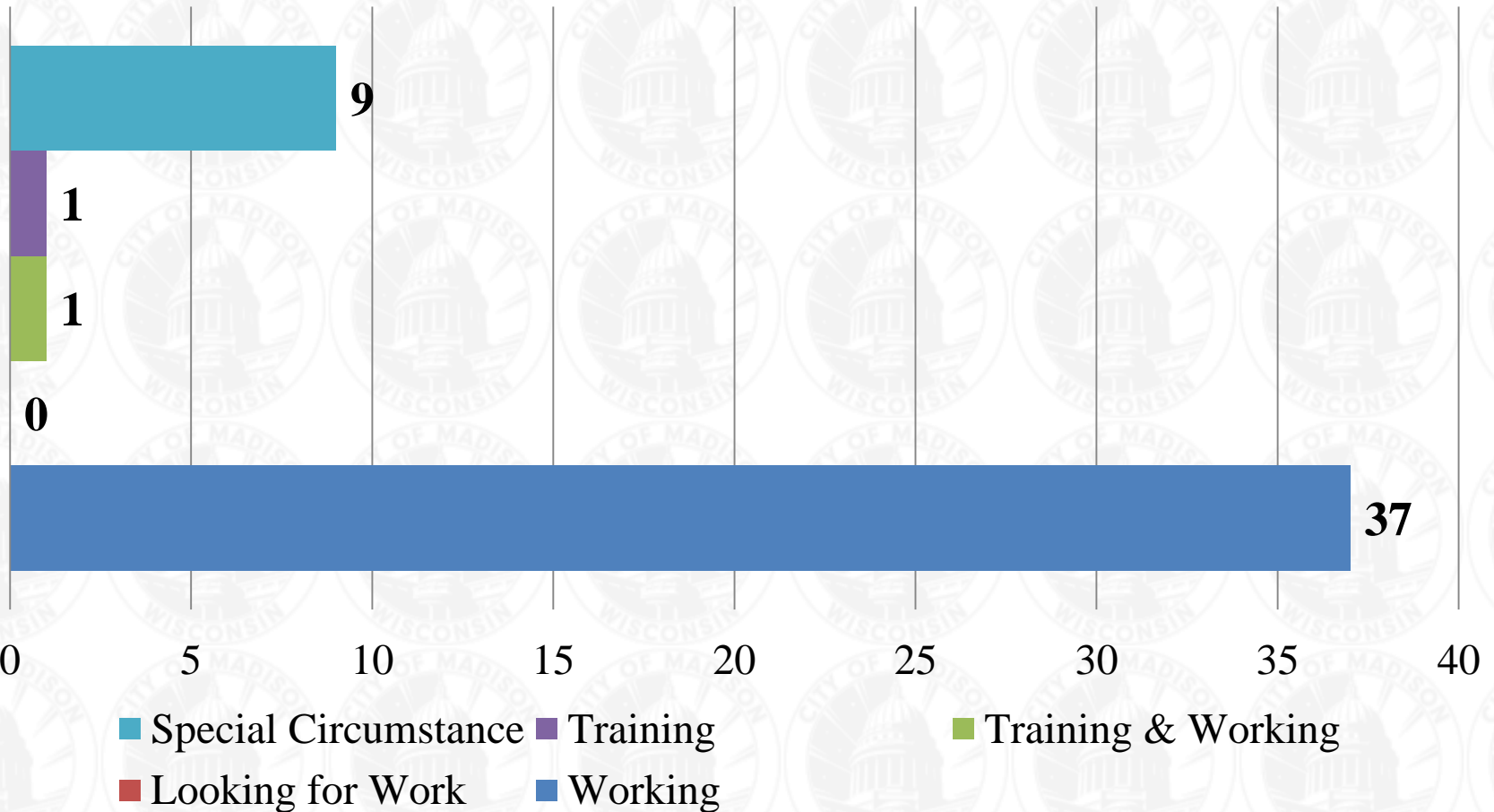
4th Quarter 2016 Spending



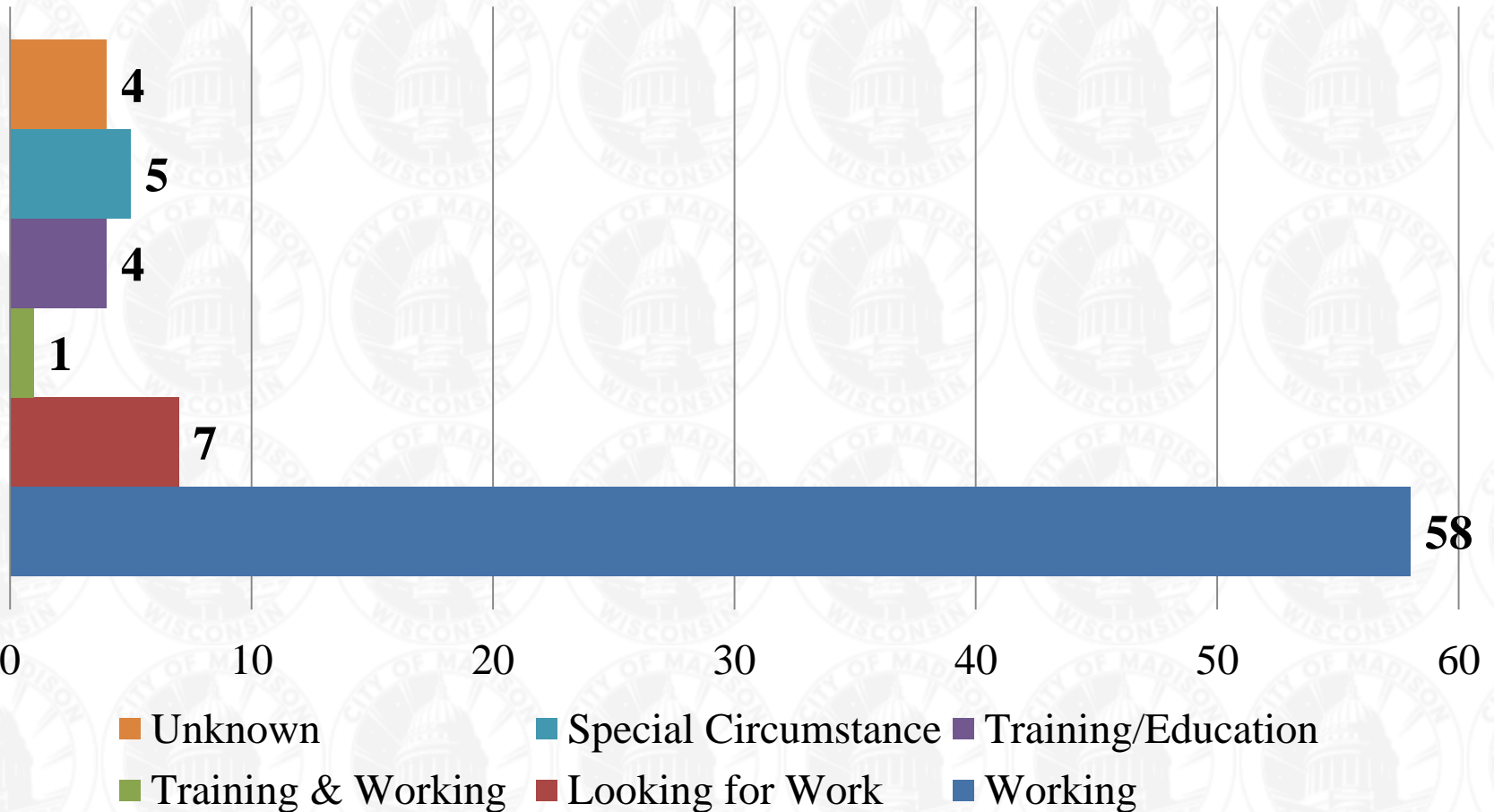
4th Q 2016: Children Served

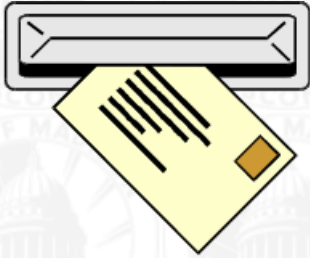


4th Q 2016 Families Served: Employment Status

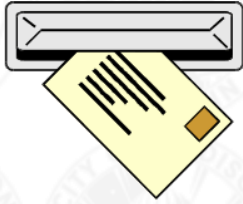
