We would like to replace 37 windows with double hung Reynolds vinyl replacement windows into existing frame openings. Interior trim will not be disturbed and the new windows will butt up to existing stops on interior. The exterior trim will be wrapped with aluminum. The reason for replacement is that many of the windows are failing or non-functional as well as very inefficient. The windows no longer have the original glass in them. 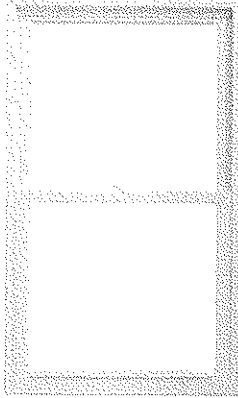
