Hi all,

I write to you as a resident of Madison in support of resolution 83214, Item 38.

On May 1st, on my way to work, I stopped by the encampment at Library Mall to show support to students who are protesting a war that has killed 15,000 children. I was shocked to see what looked like hundreds of officers. It was an absurd scene - a few dozen predominantly 18 and 19 year old kids with signs, and hundreds of officers with guns. When I arrived, around 8:00, it was a peaceful stand-still at the moment. I went to take a picture of the absurdity of it, then was standing in the background (away from where most students and police were). I was texting the picture to my partner, when about 8 or so MPD officers started running towards me and a small group of others who were standing in the background. To be clear, I was sending a text message looking at my phone, there were others who were standing around observing who looked like they had stopped by on their way to work as well. There was no threat or risk.

Within seconds, MPD ran up and knocked me and others to the ground, knocked things out of our hands. Others ended up with officers' knees on their heads. It was an absurd and unwarranted escalation tactic that made everyone less safe and served no functional purpose.

Not only was it a lapse in ethics, it was a clear lapse in strategy. What purpose does it serve to escalate a peaceful demonstration in those ways? What purpose does it serve to, without conversation, without seeking to understand, knock people to the ground? Most concerning of all is that in review, I am sure MPD will find that officers acted clearly within the bounds of their SOPs. I urge you to vote in favor of this resolution.

I understand that this evening you will be voting on a resolution calling for Chancellor Mnookin to allow the UW-Madison student encampment to remain, free from threat of law enforcement. Although I am writing you as a private citizen, my role a UW faculty member who has spent hours in or near the encampment—including when it was raided by law enforcement—shapes my writing indelibly.

I saw my students students who are passionate about sustainable agriculture—about how we make science relevant to the public—students who have brilliant ideas but needed a bit more structure to help their argument flow out of their topic sentences—students who critiqued the ideas I presented in class in a way that led to deeper learning for the class as a whole—students who are SO ready to be done taking classes so they can go and make the world a better place—on the morning of 5/1 I saw their bodies smashed up against riot shields and my eyes welled up with tears. You've seen the videos I'm sure. Students stood their ground to protect what they had built against the heavy hand of the state that was called in by this university's highest ranking official. My students deserve better. They deserve the safety THEY created, not the danger imposed upon them by the Chancellor.

When speaking about the encampment, Chancellor Mnookin keeps saying that it needs to be removed not because tents in and of themselves are a threat, but because the camp is a magnet for unsafe activity. Should we stop building schools because they are a magnet for school shootings? Should we stop creating businesses because they are sites of fraud? Should we close our public parks because people sneak in drugs? The tents are not a threat; the encampment is not a threat; our students are not a threat. They should be protected and cherished and engaged with in a substantive, meaningful way.

I am writing to you with shaky hands and a broken heart as I bear witness to the unimaginable carnage being carried out in the city of Rafah right now....and with regard to item #38 of the City of Madison's Common Council agenda.

As a Jewish person and a person of conscience proudly born and raised in the city of Madison, I implore you to support the UW Madison student encampment and to halt any and all disciplinary action against these remarkable and courageous students who are willing to risk everything to protest the Israeli state-sanctioned genocide against Palestinians. I hope you are all as proud as I am of the tremendous tenacity of our students. I remain in awe of their bravery and steadfastness in the face of police violence and repression.

I implore you to support an immediate and permanent ceasefire.

I implore you to support the student calls for disclosure and divestment from the University.

It is because of the values imparted upon me by my public school education in MMSD and by my Jewish ancestral tradition that it sickens me to my core to watch the people and institutions I thought I respected support (or remain silent on) unconscionable and ultraviolent actions against innocent civilian populations— be they our cherished UW students or our sacred Palestinian siblings.

I implore you to be on the right side of history. This is not an issue of antisemitism. This is an issue of human rights violations and—by and large— our non consensual complicity in mass murder. With every fiber of my being I must demand that Never Again mean Never Again For Anyone.

I am often reminded of the words of the honorable Elie Wiesel (z"l), Nobel Laureate, author, and Holocaust survivor:

"Action is the only remedy to indifference: the most insidious danger of all."

"There may be times when we are powerless to prevent injustice, but there must never be a time when we <u>fail to protest</u>."

"I swore never to be silent whenever and wherever human beings endure suffering and humiliation. <u>We must always take sides</u>."

"This is what we must do—not to sleep well when people suffer anywhere in the world. Not to sleep well when someone's persecuted. Not to sleep well when people are hungry all over

here or there. Not to sleep well when there are people sick and nobody is there to help them. Not to sleep well when anyone somewhere needs you."

I write to urge you NOT to support the proposed resolution from Alders Bennett, Rummel, and Wehelie that would ask UW-Madison to affirm and permit the continued illegal encampment of anti-Israel protestors on Library Mall.

It would be truly absurd for a group of elected officials, who are here to serve the ENTIRE Madison community, to urge the UW to tolerate the flagrant violation of the law.

Dear Alders,

I strongly urge you to support the resolution "Supporting Student Organizers & Reaffirming Commitment to Peaceful Resolution," although I must say, it is extremely disappointing that the substitute resolution takes out any policy change or accountability for the ways in which Madison Police Department participated in, and escalated, the aggressive crack-down on the peaceful encampment on May 1st.

On Wednesday morning, 4/1, I went down to the encampment to support the students and be an observer and was horrified by the level of state violence I saw enacted against a group of peaceful protestors standing up against a war that has killed over 14,000 children in 6 months. Not only were there State Troopers in riot gear, UW Police, the Dane County Sheriff's Deputies, but there were also Madison Police officers actively participating in the aggressive and violent suppression and arrest of protestors. It was one of the most shocking displays of state violence during a protest I have ever seen in Madison.

We should be embarrassed by the actions of our Madison Police and the violence they were an active part of facilitating against young people – students – and professors who call Madison home and were there to protect their students. As a city that prides ourselves on being a bastion of free speech with rich civic engagement and a proud history of protest we should be alarmed and ashamed of the actions of our police department, and the leadership from our city and the University that endorsed and enabled it.

Finally, I strongly urge you to reaffirm our city's call for a Permanent Ceasefire in Gaza. The level of destruction of Gaza and human suffering is unconscionable. We as taxpayers continue to bankroll a war on Gaza to the tune of billions of dollars and it has consequences for what we can invest in to support residents in our own communities. I am in strong support of our UW students joining with thousands of students across the country to demand that University divest from the ongoing brutal war on Gaza and no longer be financially complicit in what the International Court of Justice has ruled a plausible genocide. Support for students' right to protest on campus without retaliation or police action is inextricably linked to the complicity of our own administration in these deaths. We urge the Common Council to support student demands for divestment from and disclosure of the University's investments in this ongoing genocide.

In addition, we also call for the demilitarization of our campus community. On May 1st, 2024, UW Chancellor Jennifer Mnookin ordered the use of force by UWPD, MPD, the Dane County

Sheriff's Office, and State Patrol against students, faculty, staff, and community members gathered at the Gaza Solidarity Encampment on Library Mall. Regarding Legistar File #83214 (Agenda #38), I oppose this resolution. While I long for a ceasefire and a peaceful resolution to the very serious conflict in Israel/Gaza, this resolution goes ridiculously far when talking about local policing. It is political grandstanding on full display.

Don't lose focus on the jurisdiction responsible. Event facilitators should have been in contact with UWPD, not MPD, as the event was within the jurisdiction of UWPD and they were the lead agency. And UWPD apparently requested the help of MPD in maintaining a safe perimeter while UWPD removed the tents, which were up in violation of campus policy and state law, more than 15 minutes after a lawful command went out to remove them. It seems that MPD did their job and promptly left.

The fact that you go so far as to "order" MPD Chief Barnes to change an SOP that already has the same values is an overreach. MPD does not "direct officers to interfere with the lawful exercise of free speech." And to insinuate it did in this case, through a resolution, is irresponsible.

The MPD OIC was not in charge of the events with protestors on the UW campus. MPD was fulfilling a specific, lawful role and function, they were not the agency in charge. Perhaps you should take up your concerns with UWPD. But in any case, the events that unfolded, at least by some in the crowd, deviated from "the lawful exercise of free speech," as you can see in the video linked below and read about in the article.

I imagine this will pass under the optics of appearing politically correct, but I hope Alders will look at the final focus of the resolution and realize an Order directing the Police Chief is unnecessary, foolish,and ridiculous.

As your resident, I would encourage you to vote no on either version of Item #38. Not because I don't support peace in Israel/Gaza (because I do), and not because I don't support the rights of students and faculty and every single resident to safely exercise their first amendment rights (because I do), but because this is a political charade and publicity stunt and it's not even limited by facts and reality.

The original version of this resolution should not have made it past the City Attorney's Office.

The Common Council did not ban the Madison Police Department from performing chokeholds in September 2020 (or ever). If MPD ever used them, they haven't been using them over the past 40+ years. They were (and are) prohibited except in the rare case when deadly force is justified, and I don't know of any instance they were used even then.

This is from Chief Wahl's blog in July of 2020, when the 8 Can't Wait campaign was in full swing and he was responding to residents' emails about MPD's related policies:

"Ban Chokeholds & Strangleholds –

MPD does not, nor has it ever, trained officers in chokeholds, strangleholds or any other similar techniques. MPD policy specifically prohibits use of these techniques unless deadly force is justified."

The Common Council had nothing to do with banning chokeholds. Yet the sponsors wanted to memorialize that lie (and others) in a public, legal resolution This is not proper conduct for an elected member of the Madison Common Council. Please check the veracity of the facts before including them in your resolutions. It seems that after some facts were checked, quite a bit of the first version was changed (notably the part about three elected officials being pushed at the Fluno Center).

I have communicated my thoughts on Version 1 in another email, so now I will limit myself to Version 2.

The freedom of speech, protected under the first amendment to our U.S. Constitution,

is a beautiful thing. Not all countries, territories, and governments guarantee, or even value it (including one mentioned in your resolution). I studied first amendment rights deeply while pursuing my degree in Journalism. It's a fundamental right (in the U.S. and Israel) and I would defend it to my death. However, the moment the encampment went up, it introduced illegal activity, which is not protected under the first amendment. Setting up tents broke State law and University policies. It was illegal. And when those with tents refused lawful orders to remove their tents, set up illegally, and the State and University gave the command to enforce the law on the books, that is not escalating anything. Police officers were carrying out their sworn duty to enforce the law. When students and others decided to disobey that order, and instead began pushing into police officers and the shields they carried for their own protection, that caused the escalation. That is another illegal behavior not covered by first amendment rights, for at least 3 violations of the law: initially violating the law of no tents set up on university property, then disobeying a lawful order to remove them, and then resisting, obstructing, or battering a law enforcement officer. It takes at least two parties to successfully de-escalate a situation.

In this resolution, the Madison Common Council **commends those engaging in civil disobedience**, another activity not protected under first amendment rights. And not something I would want to support as an elected member of the Common Council. The Constitution does not guarantee any right to engage in civil disobedience, which, by its very definition, involves the violation of laws or regulations.

It is the duty of all sworn personnel to defend the first amendment rights of individuals on University grounds (and elsewhere), while at the same time minimizing the disruption to regular activities on the University campus (and elsewhere) and upholding public safety. All sworn personnel have a duty to protect all persons from physical injury as well as defend the University from property damage caused by civil disobedience. Officers may use reasonable force, according to their policy and under the law, in order to accomplish these goals.

To Alder Madison's point about taking the role of Alder seriously, when I look at the role of an Alder found on the City's site, this resolution seems like quite a stretch.

To Alder Tishler, thank you for being an Alder who listens to your constituents and engages respectfully with all. Please take no offense that I did not CC you on my email to Alder Madison. That was in response to her recent blog post and seeing that she had added her name as a sponsor. I didn't need to waste your time with this. Thank you for engaging with your constituents and taking a \$27 million budget deficit seriously and not minimizing it (even though you haven't been in the role as long as Alder Madison). I greatly appreciate your leadership,

Body

WHEREAS, on December 5, 2023, the Madison Common Council unanimously passed two resolutions: one calling for an immediate ceasefire in Gaza and urgent political action to deescalate the crisis and to prioritize truth, reconciliation, restitution, and the building of a future for Palestinian and Israeli people, and the other condemning all acts of Islamophobia and Anti-semitism and encouraging all Madisonians to recognize the diversity of religions as a source of strength and to foster an environment of open and constructive dialogue that provides a supportive space to engage in these crucial conversations; and,

WHEREAS, according to Al Jazeera, the Gaza Ministry of Health reports that armed violence has claimed the lives of over 34,500 people, including more than 14,000 children, as well as over 1,100 Israelis; and,

WHEREAS, the devastation and death continue with horrific news of a mass grave uncovered at Nasser Hospital in Gaza which included bodies shot in the head; and,

WHEREAS, according to Al Jazeera and the United Nations, 24 hospitals have been partially or totally destroyed and at least 53 schools have been totally destroyed; and,

WHEREAS, this conflict is perpetuating a dangerous and costly lack of access to basic human needs in Gaza, such as food, water, medical supplies, and more, which are indispensable for the survival of the civilian population; and,

WHEREAS, for the safety and security of all civilians and in order to provide humanitarian aid to Gaza, any ceasefire must be agreed upon by both sides and must be guaranteed by the physical presence of international partners who have a vested interest in seeing peace and stability in the region; and,

WHEREAS, it is reported that both Israel and Hamas attacked and seized hostages and there is unclear reporting on the state of said hostages; and,

WHEREAS, after over 200 days of violence, leaders have not yet successfully enacted a permanent ceasefire; and,

WHEREAS, students at over 120 universities across the United States, including the University of Wisconsin-Madison, have organized peaceful protests and encampments to express their first amendment rights and have demand for a permanent and immediate ceasefire, divestment, and action from campus leaders and elected officials; and,

WHEREAS, on Monday April 29, University of Wisconsin-Madison students began the Popular University for Gaza encampment at Library Mall, joining over 100 universities across the globe participating in encampments in support of an immediate and permanent ceasefire in Gaza, which further called for the University of Wisconsin-Madison to divest from occupation, borders, and prisons from Palestine to Teejop; and,

WHEREAS, on April 29, the Wisconsin ACLU issued a statement in support of students right to free speech and reminded us that "university administrators are left with a choice - one that will determine which side of history they will be on. They can stay true to the Wisconsin Idea - the founding principle of our state university system - which holds that college campuses must serve as incubators for self-discovery and empower students to critically examine, understand, and interact with the world around them. Or they can, regrettably, decide to follow the path of other universities that have succumbed to political pressure, betraying and punishing their students, faculty, and staff for peacefully exercising their right to dissent"; and,

WHEREAS, UW-Madison administration and the University of Wisconsin Police Department (UWPD) should share the priority of maintaining safety and protecting first amendment rights to free speech; and, WHEREAS, clear communication and de-escalation from UW-Madison administration and UWPD is essential to maintaining safety and protecting first amendment rights to free speech; and,

WHEREAS, during the week of April 29, 2024, Madison area elected officials responded to the peaceful protest at Library Mall to listen and ensure the safety of all involved, despite the lack of clear communication from law enforcement; and,

WHEREAS, on April 29, 2024, the Wisconsin State Patrol and UWPD physically pushed two Madison alders and a Dane County Board Supervisor at the Fluno Center as they were operating in their capacity as elected officials to represent their constituencies; and,

WHEREAS, on May 1, 2024, UWPD, Madison Police Department (MPD), Dane County Sheriff (DCSO), and Wisconsin State Police organized and initiated an escalation tactic through executing a raid on the peaceful protest and encampment at Library Mall, resulting in numerous arrests and eyewitness reports of student and faculty injuries that resulted from police brutality; and,

WHEREAS, during the raid on May 1, 2024, there were numerous eyewitness reports and photographic evidence of UWPD, DCSO, and state troopers using violent tactics, including the use of batons, knees on the upper back, stripping clothes, chokeholds, and other forms on physical violence on UW-Madison students and faculty; and,

WHEREAS, in MPD's Standard Operating Procedures (SOPs) for "Demonstrations and Assemblies," one of the principles states that "communication between police and event organizers before and during events can create mutual understanding, generate cooperation and compliance, and prevent disorder"; and,

WHEREAS, on September 1, 2020, the Madison Common Council created Section 5.16 of the Madison General Ordinances to prohibit Madison Police Department employees from intentionally using carotid or neck restraints; and,

WHEREAS, numerous UW-Madison campus and local organizations, UW-Madison faculty and staff, elected officials, and a broad range of local supporters have called on Madison area law enforcement to discontinue the raid on the encampment and use of force on students and protests;

Yet the sponsors wanted to memorialize that lie (and others) in a public, legal resolution This is not proper conduct for an elected member of the Madison Common Council. Please check the veracity of the facts before including them in your resolutions. It seems that after some facts were checked, quite a bit of the first version was changed

(notably the part about three elected officials being pushed at the Fluno Center).

I have communicated my thoughts on Version 1 in another email, so now I will limit myself to Version 2.

The freedom of speech, protected under the first amendment to our U.S. Constitution, is a beautiful thing. Not all countries, territories, and governments guarantee, or even value it (including one mentioned in your resolution). I studied first amendment rights deeply while pursuing my degree in Journalism. It's a fundamental right (in the U.S. and Israel) and I would defend it to my death. However, the moment the encampment went up, it introduced illegal activity, which is not protected under the first amendment. Setting up tents broke State law and University policies. It was illegal. And when those with tents refused lawful orders to remove their tents, set up illegally, and the State and University gave the command to enforce the law on the books, that is not escalating anything. Police officers were carrying out their sworn duty to enforce the law. When students and others decided to disobey that order, and instead began pushing into police officers and the shields they carried for their own protection, that caused the escalation. That is another illegal behavior not covered by first amendment rights, for at least 3 violations of the law: initially violating the law of no tents set up on university property, then disobeying a lawful order to remove them, and then resisting, obstructing, or battering a law enforcement officer. It takes at least two parties to successfully deescalate a situation.

In this resolution, the Madison Common Council **commends those engaging in civil disobedience**, another activity not protected under first amendment rights. And not something I would want to support as an elected member of the Common Council. The Constitution does not guarantee any right to engage in civil disobedience, which, by its very definition, involves the violation of laws or regulations.

It is the duty of all sworn personnel to defend the first amendment rights of individuals on University grounds (and elsewhere), while at the same time minimizing the disruption to regular activities on the University campus (and elsewhere) and upholding public safety. All sworn personnel have a duty to protect all persons from physical injury as well as defend the University from property damage caused by civil disobedience. Officers may use reasonable force, according to their policy and under the law, in order to accomplish these goals.

To Alder Madison's point about taking the role of Alder seriously, when I look at the role of an Alder found on the City's site, this resolution seems like quite a stretch.

To Alder Tishler, thank you for being an Alder who listens to your constituents and

engages respectfully with all. Please take no offense that I did not CC you on my email to Alder Madison. We urge the Common Council to support student demands for divestment from and disclosure of the University's investments in this ongoing genocide.

In addition, we also call for the demilitarization of our campus community. On May 1st, 2024, UW Chancellor Jennifer Mnookin ordered the use of force by UWPD, MPD, the Dane County Sheriff's Office, and State Patrol against students, faculty, staff, and community members gathered at the Gaza Solidarity Encampment on Library Mall. Countless students and faculty were assaulted by these forces and forcibly detained. Four of those arrested were booked into the Dane County Jail and are facing charges. In addition to denouncing this use of force by the University, we also urge the Common Council to call for these charges to be dropped. The call for charges to be dropped goes hand in hand with the reduction of funding for police on campus and the increase in funding for community social services—from UHS to affordable housing and tuition remission.
