Dear Parks Commissioners,

I attended the meeting with Madison Mallards reps in March. Along with most in attendance, I voiced my dislike of their fireworks displays and my opposition to their request to add two more dates. As I commented at the meeting, some assumptions and statements need to be challenged. The Mallards are undeniably good neighbors to the Northside in many respects. This does not mean they are quid pro quo entitled to set off fireworks as often as they like, or at all. Women's collegiate summer softball is a great addition to their game lineup, but not necessarily one that deserves being rewarded with an additional fireworks date. In fact, as others at the meeting also pointed out, the basic assumption that fireworks displays are the default and only possible post-game entertainment is flawed, and one which your continued permission has encouraged over the years. Many other options are available which wouldn't involve inflicting shock and awe on every human and non-human neighbor for miles around, for the amusement of a small subset of people and to the benefit of a business enterprise that seeks to profit at our expense. (In fact it might be interesting to ask how beer sales compare on game nights with and without fireworks.) Several attendees spoke of their enjoyment of these events and pointed out that their pets aren't bothered by them. Of course not every pet minds fireworks (though many do). Nor do most of our neighbors suffer from PTSD or other trauma. The moral question these supporters don't address, and you must, is whether their right to ooh and ahh is more important than others' right not to be terrorized. If I don't care for a monster truck rally, or you for a flower show, we can choose not to attend. Fireworks are not escapable (unless, as supporters callously suggest, those who object move away, leave town for 6-8 nights each summer, or take refuge in their basements.) Fireworks are not benign; they disrupt wildlife, traumatize pets and vulnerable people, and emit toxins into the environment. Moving the launch site a few yards in one direction or another, changing the dates by a few days, or making them slightly quieter, doesn't alter the fact that the whole point of these explosives is to evoke the thrill of aerial bombardment. Why do we assume that the rights of those who enjoy and profit from this spectacle should override those of neighbors to the quiet enjoyment of their homes? Fireworks used to be, and should be, one night per year. Under your tolerant watch they have metastasized and will continue to do so, unless you accept your responsibility to make decisions in the best interest of the vast majority of Northside residents, human and animal alike. Please vote against agenda item on 4/8.
