



5K Route



- > Start/Finish is in front of the pavilion at the south side of the Warner parking Lot.
- > Runners start by heading east and exit the parking lot heading towards N Sherman Ave
- > Right on N Sherman Ave
- > Right on Trailsway
- > Continue straight on trail that goes through park to the west
- > Left at the trail junction in the park
- Right on Sheridan Dr at end of trail
- Right on Woodward Dr. (Runners use both sides of Woodward Dr. No Traffic between Sheridan Dr and Forster Dr.
- > Runners turn around in middle of the street in front of the Warner Park Beach House
- > Left on Sheridan Dr
- > Left on Wyldwood Dr -
- > Left on Monterey Dr
- ➤ Right on Trailsway
- > Left into the blke lane on Sherman Ave
- > Left in the parking lot to the finish



- > Start/Finish is in front of the pavilion at the south side of the Warner parking Lot.

- > Right on N Sherman Ave
- > Right on Trailsway

- Right on Woodward Dr towards bath house. (Woodward Dr. is fully closed between Forster and Sheridan)
- > Left on Sheridan Dr
- > Left on Wyldwood Dr
- > Left on Monterey Dr
- > Right on Trailsway
- > Left into the bike lane on Sherman Ave
- > Left in the parking lot to the finish
