Contract 9562 is for the public improvements required for the redevelopment at 1024 Milton Street (currently addressed as 29 S Mills Street) by Neighborhood House Ventures, LLC. Improvements include reconstruction of the existing public sidewalk and terrace on S Mills Street and Milton Street and replacement of any curb or pavement needed. The Developer will also construct new private service laterals (sanitary, storm, and water) to serve the redevelopment as well as a new private drive entrance. Existing street trees are to be protected, removed, or replaced as approved and required by City Forestry, including any recommendations for potential long term canopy improvement, if planned utility work provides opportunities. The Developer will also coordinate the relocation of any private utilities (electric, gas, phone, etc.) necessary for the redevelopment.

The water utility project's involves the directionally drilling of a transmission water main beneath interstate 39 & 90 to enhance the regional water supply system. This method minimizes surface disruption and environmental impact while ensuring a reliable connection between key water infrastructure. The project includes advanced drilling techniques to navigate existing underground utilities and geological conditions, ensuring safety and efficiency. By completing this installation, the utility aims to improve water distribution capacity, reduce the risk of outages, and support future community growth. Regular monitoring and assessments will be conducted throughout the project to ensure compliance with safety and environmental standards. The total estimated cost of the project is \$2,000,000.
