Parks will share the survey results and comments with the Lake Monona Waterfront Ad-hoc Committee. The Committee will consider the public input during their plan evaluation, which is scheduled to occur in April.

After selecting a preferred plan, the Committee will work with the respective design team to refine the option prior to submittal to the Common Council. The Council submittal is anticipated in August, and the plan will be referred to various City committees for further review.
