Report of Subcommittee on Nightclub & Performing Arts Ordinance Revisions

15. 04765 October 16 meeting on Nightclub and Performing Arts License revisions.

Ms. Rearick reported that the subcommittee had talked about tightening up the Nightclub and Center for Visual & Performing Arts licenses. She said the subcommittee recommends that Performing Arts license applicants be required to submit a security plan. The subcommittee also recommends that establishments be required to hold a Center for Visual & Performing Arts license in order to have patrons ages 18 and up when their focus becomes entertainment. The subcommittee had talked about renaming the licenses the 21+ Entertainment License and the 18+ Entertainment License.

Attorney Zilavy will incorporate these recommendations into an Ordinance to be introduced by Alderpersons Olson and Verveer.

Madison has a quota of 399 Class B Combination Liquor & Beer licenses under state law. 56 of 74 Reserve licenses have been granted. 291 of 325 Grandfathered licenses have been granted. Taking into consideration the licenses recommended to Council to Grant at tonight's meeting, 50 Class B Combination licenses are currently available in the City of Madison.
