The goal of MPD's traffic safety efforts is to increase voluntary compliance of traffic laws through the use enforcement and education opportunities. In addition to routine traffic enforcement activities conducted by officers, citizen complaints of problem areas help to shape enforcement actions, education efforts and partnerships with others in our community.

Attached to this summary letter is the Madison Police Department's Traffic Enforcement Quarterly Activity Report for the fourth quarter (October-December) of 2006 which included final year-end totals, Speeders Hotline report, and excerpts of the categorical breakdowns from the quarterly report (requested by PBMV).

Other selected traffic activities include:

- On going school zone enforcement that included TEST, CPT, Parking Enforcement and patrol officers
- ❖ Designation of a Education-Enforcement officer in TEST
- ❖ Focused enforcement effort on E. Washington Ave during construction periods
- ❖ Scheduling of traffic enforcement during football Saturdays and other high traffic events
- ❖ Traffic Summits focused on 8 to 15 year old youths
- ❖ Participation in WI DOT-BOTS grant funded programs: Alcohol, Aggressive Driving, Pedestrian, Speed and Bike
- ❖ Participation in Safe Community grant funded enforcement: Pedestrian, Red, Yellow, Green
- ❖ Adult Crossing Guards participating in traffic safety efforts

Total citations issued for 2006 were 21,075, which include 14, 959 hazardous violations and 6,216 non-hazardous violations. Increased hazardous citations issued included OMVWI (B); Speeding; Stop and Go; Arterial; Passing/Turning in addition to several other categories. These violations are many times crash related and/or a causal factor in a crash.

MPD received 2,424 calls to the Speeders Hotline during the year and 1,766 letters were mailed out when adequate identifying information was available. No action was taken on 658 reports.
