## c. Capital Campaign Update

Mr. Sherry noted the campaign cabinet had a 2<sup>nd</sup> meeting and was well attended. Most people from the contact list have already been contacted or the appointments are scheduled.

## **B.** Financial Report

#### a. November 2015 Financials

Ms. Phillips reviewed the report and notes that Revenue is up \$125,000 (\$114,000 due to Special Events) and Expenses are down \$34,000.

### b. Approval of 2016 OBS Operating Budget

It was noted that the past few years have each had a 5% increase in total budget over the previous year, but that each year the budget is 'built' by each section and combined for the final budget..

A motion was made by Mr. Lauffer and seconded by Ms. Ogden to approve the 2016 OBS Operating Budget. Motion carried unanimously.

# c. Capital Campaign Budget (not on agenda)

A copy of the 2016 Capital Campaign Budget is enclosed in the packet. Ms. Sladky discussed how she put the budget together. It is noted that "regular" staff time is not included in this number, but Ashlyn Mehlhaff position is. It is suggested that including a basic % of time other staff spend on the Campaign would be useful information, even if not included in budget numbers.

A motion was made by Mr. Wagner and seconded by Ms. Ogden to approve the 2016 Capital Campaign Budget. Motion carried unanimously.

#### C. Director's Report

Ms. Sladky reviewed staff reports. The Holiday Show Preview Party was very well attended – record crowd. The warm weather has allowed the Horticulture staff to continue outdoor projects and that should help when spring rolls around. Ms. Sladky thanked the Board members and staff for a successful 2015.

### D. Development and Marketing Staff Update

Katy Morgan-Davies provided information re: William Wartmann and previous donations to support the Children of the Rainforest programs. Mr. Wartmann requested a letter from the Board that acknowledges his donation will also be used to provide transportation to people who request assistance in getting to and from the event.

A motion was made by Mr. Wagner and seconded by Mr. Sherry to respond to the donors request for a letter from the Board re: donation to be used for program and transportation as needed. Motion carried unanimously.

Update – staff are waiting to hear from Adams Outdoor Advertising in regards to Olbrich being selected as one of their "sponsor partners".

## **E.** Development Committee Report

Ms. Covelli reports the committee didn't meet this past month, but the committee plans to reevaluate what their role is, how best to assist staff, etc... She noted that social media continues to be used more and more and that Olbrich is getting assistance from professionals in that area to show us best ways to use it.
