Title

Creating Section 8.19(1)(a)3. and amending the title of Section 8.19(1) of the Madison General Ordinances to prohibit dogs in any portion of a building that is occupied by the City.

Body

DRAFTER'S ANALYSIS: This ordinance prohibits dogs from entering or remaining in any building or in any portion of a building that is occupied by the City. Section 8.19(1)(b), MGO, provides an exception for service dogs and law enforcement dogs, this exception would apply to this ordinance.

The Common Council of the City of Madison do hereby ordain as follows:

1. Paragraph 3. entitled "Dogs in City Work Places" of Subdivision (a) entitled "Prohibition" of Subsection (1) entitled "Dogs Prohibited in Parks and on School Grounds" of Section 8.19 entitled "Animals Prohibited in Certain Areas" of the Madison General Ordinances is created to read as follows:

"3. Dogs in City Work Places. Dogs are prohibited from entering or remaining in any building or portion of a building that is occupied by the City."

2. The title of Subsection (1) entitled "Dogs Prohibited in Parks and on School Grounds" of Section 8.19 entitled "Animals Prohibited in Certain Areas" of the Madison General Ordinances is amended to read as follows:

"(1) Dogs Prohibited in Parks, and on School Grounds, and in City Building Spaces."
