### **Security Plan**

Karaoke Nights at Laredo's

#### **Main objective:**

Our main business is to provide the City of Madison with authentic Mexican food, in our efforts to better serve our customers and the community we have Karaoke nights at Laredo's, this will help the community enjoy multicultural music as well as entertainment for the whole family. We host around 30 customers at Karaoke nights; our plan is as follows:

#### **Staff Arrangement**

##### **Bartender:**

There will be a bartender at all times to check, supervise and serve the bar area. This bartender will be in charge of checking for proper IDs, if in doubt, a second type of identification will be requested. The bartender will request proof of age and will refuse service to any customer that cannot produce an adequate ID. When a customer has been cut-off, the bartender will notify the other employees. Management will support the server decision to terminate service to any customer. If the customer is too impaired to drive safely, we will arrange for a safe drive, if the customer refuses the Madison Police will be notified with a description of the vehicle and license plate.

##### **Waitresses:**

There will be a waitress cleaning and waiting on people as well as checking for alcohol consumption.

##### **Manager:**

A full time manager is assigned to make sure everything is running according to this plan starting from security, alcohol consumption and security of the establishment.

There will be the manager determination if the police will be called for assistance. The call will be in a timely manner.

##### **Building and Exit system:**

There are two exits on the side of the bar area that will facilitate the emergency exit to our customers in case of an emergency.

Video Cameras are mounted to cover different areas of the restaurants including the entrance.
