As residents of the neighborhood for 35 years, the opening of bars along Williamson is a concern. This neighborhood had promoted it's families and schools- but appears now to prefer drinking and partying.

Please have Central Park closing time be a firm 10:00 P.M. People disperse and equipment removed at closing, so residents can enjoy their homes too.

Also parking is at a premium in this area, and the planning of this park, with events did not include parking.
