
Just updating you on materials for the rear deck. The customer has selected Trex in the clamshell color for the decking material. Trim for the deck will be cedar painted to match the existing trim color (cream). Deck railing will be the ADI RailFX horizontal cable rail in black. Please find photos of the decking and railing below.





I've also attached some photos of the exterior of the home from the public right of way. There is a very small sliver of area between the 919 and 915 Spaight St. but the gap is never large enough to identify features of the back yard. From the east side of 919 you can see a portion of the back yard but none of the area where the proposed deck will be (note that deck does not go east of the large tree in the rear of the lot and the truck of the tree is not visible).
