On a motion by Host-Jablonski, seconded by Slayton, the Urban Design Commission nominated Woods as Vice-Chair, on a vote of (6-0-2) with Woods and P. Wagner abstaining.

UNFINISHED BUSINESS

1. 04545 9701 Brader Way - PUD(SIP), Signage Package for a Previously Approved Office Building (Baer Insurance). 9th Ald. Dist.

The motion for approval provided for upper parapet wall signage according to the provisions for "Option B," including all other signage elements as proposed, except for the uplighting with ground fixtures for the main monument sign, along with any

necessary modifications to the landscape plan as needed in regards to the monument sign.

A motion was made by Barnett, seconded by Cosgrove, to Grant Final Approval. The motion passed by the following vote:

 8 Straubel Court - Public Project and Alteration to an Existing P.R.D. for a Handball Court. 17th Ald. Dist.

The motion provided for the elimination of shrubs with the addition of three or more trees (river birch) off of the northeast corner of the handball court structure, along with the inclusion on the exterior two walls of either Euonoymous vine, in combination with any Parthenocissus, Boston ivy or Virginia creeper for color and texture planted at no less than 10-feet on center.

A motion was made by Slayton, seconded by Host-Jablonski, to Grant Final Approval. The motion passed by voice vote/other.

3. 02988 505-550 Midvale Boulevard, Midvale Plaza Redevelopment, PUD(SIP), Mixed-Use Development, Alterations to Previously Approved Plans. 11th Ald. Dist.

The motion required the following:

- Pull the line of planters back to parallel with the face of the building to open up corner seating area.
- Adjust handicapped access ramp at corner to provide for two curb cuts at 90 degrees to replace the single diagonal curb cut.
- Provide salt tolerant plantings in lower planting bed along Midvale Boulevard.
- Adjust benches at the face of the building to provide a 90 degree orientation with an additional bench provided adjacent to the Midvale Boulevard façade.
- Consider crowning the yew bed adjacent to the Midvale Boulevard frontage to provide drainage to the sidewalk area.
- Add an additional tree on both sides of the corner.

A motion was made by Host-Jablonski, seconded by Woods, to Grant Final Approval. The motion passed by voice vote/other.

NEW BUSINESS

4. 07752 115 West Doty Street - Public Building. 4th Ald. Dist.

The motion noted that this consideration is a stopgap measure for a building located in a bowl; any future expansion of building communication towers should be integrated as part of the architecture of the vertical expansion.
