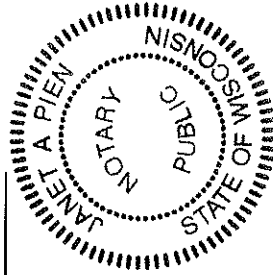

SUBJECT: Mayfair Street Assessment District-2007

The City of Madison Board of Public Works was unable to vote on the approval of plans, specifications and the schedule of assessments for the Mayfair Avenue Street Assessment District-2007 at their May 2, 2007 meeting, because there wasn't a quorum present. This item will be included on the agenda for the May 16, 2006 Board of Public Works Meeting for discussion during the regular meeting held at 4:30 p.m. in Room 103A of the City County Building, 210 Martin Luther King Jr. Blvd. This is not a public hearing, but the public will be allowed to ask questions and provide input on the project. We apologize for any inconvenience this delay may have caused for residents to attended the May 2 meeting.

A second public hearing for this project, before the Common Council, is tentatively scheduled for June 5, 2007. A notice of the public hearing will be mailed approximately ten (10) days prior to the meeting.

The current design includes a thirty-two (32) foot wide street with concrete curb and gutter and sidewalk on both sides of the street. The sidewalk along the westerly side of the street, adjacent to the residential properties, has been moved five feet closer to the roadway. The new location will allow the sidewalk to be constructed slightly above the top of the curb, yet will keep the grading and fill limits within the public right-of-way.
