Type of live entertainment to be offered: Mostly small acoustic groups, playing during the dinner hour

Number of security personnel and how they will be utilized: This is a small european-style restaurant with a wine focus, and music during dinner service, not a music venue. Security personnel will not be needed.

Description of clothing to identify security personnel: Events will generally not be ticketed and security personnel not needed.

Plan to handle control and clearance of the parking lot during hours of operation and at closing time:  
There is no parking lot but ample parking on Allen St. It is a small restaurant and parking management is not needed.

How will the entrance line be managed and controlled: This is a small restaurant and there will never be a line for music, as it is meant to be complementary to dinner service.

Plan for unruly patrons, intoxicated patrons, and physical disturbances: As a small neighborhood restaurant, the likelihood of unruly patrons is low, but I require any employee behind the bar to attain a bartender certificate and operator license. My staff is well trained and equipped to handle this unlikely scenario.

Underage drinking and fake ID plan: I require any employee behind the bar to attain a bartender certificate and operator license. Most customers are residents walking from the neighborhood. But in this scenario, my staff is well trained and equipped to handle this situation.

Plan to control and supervise patrons under twenty-one (21) years of age: \_\_\_\_\_  
Most customers are residents walking from the neighborhood. If there are customers under the age of 21, they are almost always in attendance with their parents, for dinner. If not, all bar staff have bartender certification.

How will orderly appearance and operation of the premises be maintained in regard to litter and noise:  
As a small neighborhood restaurant with an earlier closing time, the likelihood of litter and noise is low.

However, licensed staff would attend to any unlikely scenario that might disturb the neighborhood including litter.

As the owner, I live in the neighborhood with my young children, and seek to enhance not disturb the environment.
