I just heard that Madison Metro is considering permanently moving buses from Jenifer St to Willy St -- and I want to register my "NO!" early and loudly. I work at a nonprofit on the west side and live at Stoughton Rd and Buckeye. I visit the coop at least weekly. I frequent Ace Hardware, Lazy Jane's, Weary Traveler, Banzo, and Batch. I hold meetings at Ground Zero. Our dog's groomer is in the Gateway. To add bus traffic to Willy St and further limit parking options will have a huge impact on me and my family -- and on other families who can't afford to live within walking distance of these local shops we love to support.

I appreciate that you're going to take time to think this through, and I wanted to register my perspective as part of the process. I hope you'll choose to locate the buses BACK ON JENIFER permanently.

Hi,

I am writing with a note to say I don't support routing Buses on Willy Street. I travel this street daily, and so have experienced the pilot period. I am also a frequent bus rider, especially in the winter.

My reasons include:

1. I don't believe that Willy Street is currently wide enough to safely support buses / cars / bikes / and the occasional needed parking.
2. Willy Street is already dealing with too much traffic congestion.
3. I believe that Jen Street does have the proper street width to continue to accommodate the buses.
4. I believe it's important to allow ample parking on Willy to support the area businesses.
5. I support maintaining a pedestrian and bike friendly Willy Street for gathering, shopping and eating out. I don't support adding buses which contribute to traffic noise and congestion.
6. I also think that most residents find Jen Street to be a convenient "bus stop", as here bus stops are placed near a residential area.

Perhaps Metro can continue to do what they can to reduce bus noise / beeping / braking ? That would be wonderful.
