2. SUBSTITUTE - Amending Section 3.12(10)(g)1. of the Madison General Ordinances to

change the application requirements for childcare tuition aid.

Marsh discussed proposed ordinance change to remove items D and E. Currie presented a substitute ordinance change to avoid unintended consequences of limiting participants' eligibility to Madison Forward Fund.

Substitute ordinance language keeps items D and E and adds the following

language to item E:

Council, unless the applicant is actively participating in, and receiving

payments from, the Madison Forward Fund as created by RES-21-00157 and RES-21-00724 in the year of application."

(Drafter's Note: The Madison Forward Fund is the official name of the guaranteed income pilot program referenced in the Resolutions above.)

Motion by Ramirez, seconded by Currie to approve substitute ordinance language and recommend to Council to adopt. Motion passed.

3. 69094 Future ECCEC Meeting Topics

Marsh discussed future meeting topics. March meeting will include One City and Anji Play.

Current list of topics are Conscious Discipline, Reggio Emilia, Inquiry, Nature-Based programming and Respite Care. Committee members added city efforts on child care with workforce and economic development focus and Early Care Homelessness Workgroup presentation.

4. 69093 Infant and Early Childhood Mental Health Consultant Position Update

Marsh discussed interview process this week and next week. Second interviews will follow. Potential hire to could begin in February.

5. 69095 2021Tuition Assistance & Stabilization Update

Marsh provided an overview on Tuition Assistance program spending. COVID concerns have led to temporary classroom or center closings and a decrease in enrollment for families.

Tijerino presented graphs on 2021. Tuition Assistance program spending was down, but stabilization funds increased to help offset cost of care vs. copays received.

6. 69096 ECCEC Member Update

Marsh discussed Karli Shapiro's appointment to ECCEC. Shapiro applied to be a childcare worker member and the mayor recommended appointment. Council to approve at 1/18/22 meeting. Karli will receive membership information upon Council approval.

7. <u>69097</u> Statement of Interest Forms

Murray reminded members to submit electronic Statement of Interest forms. Deadline was January 3, 2022. Clerk's Office asked committees to include on upcoming agendas.

8. 69098 Community Services Committee Report - Rebecca Murray

Murray discussed the November 17 CSC meeting. RFP for Crisis Intervention and Violence Prevention funding was determined. CSC awarded amounts were approved by Council in December. Services provided by these funds

begin January 2022.
