**Addendum to Employment Services Agreement**

This addendum, made and entered into by and between the County of Dane (hereinafter referred to as "EMPLOYER") and Thomas L. Schlenker (hereinafter, "EMPLOYEE"),

WITNESSETH:

**WHEREAS**, the EMPLOYER and the EMPLOYEE have by a separate document entitled Employment Services Agreement (hereinafter the "Original Agreement") previously entered into a contractual relationship, and

**WHEREAS**, the EMPLOYER and the EMPLOYEE now wish to extend the term of the Original Agreement for five additional years commencing at the expiration of Original Agreement on December 18, 2010 and ending at 11:59 p.m. on December 18, 2015.

**NOW, THEREFORE**, in consideration of the above premises and the mutual covenants of the parties hereinafter set forth, the receipt and sufficiency of which is hereby acknowledged by each party for itself, the parties do agree as follows:

1. The Original Agreement shall remain in full force and effect unchanged in any manner by this Addendum to Employment Services Agreement except for those changes expressly set forth herein. This Addendum to Employment Services Agreement shall control only to the extent of any conflict between the terms of the Original Agreement and this Addendum to Employment Services.
2. Paragraph 6 of the Original Agreement is amended to provide that the term of agreement shall expire at 11:59 p.m. on December 18, 2015.
3. Paragraph 10 of the Original Agreement is amended to also provide that the phrase "exclusive employ" shall not be construed to prohibit part time service as a public health faculty at an academic institution.
4. Paragraph 14 of the Original Agreement is amended to provide that the direct compensation paid to the EMPLOYEE shall be at a rate equivalent to \$140,004.80 per year which shall be modified to reflect the wage concession bargained with other employees.

**IN WITNESS WHEREOF**, EMPLOYER and EMPLOYEE have executed this Addendum to Employment Services Agreement effective as of the day and date by which EMPLOYER's authorized representative and EMPLOYEE have affixed their respective signatures, as indicated below.
